RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of November 6, 2019 ("Effective Date") by COMERICA BANK, (the "Bank"), in favor of Drunk Elephant, LLC (Borrower), a Delaware limited liability company, Drunk Elephant Holdings, LLC (Guarantor), a Delaware limited liability company, and Tiffany Masterson (collectively referred to hereinafter as the "Grantor").

WHEREAS, pursuant to the terms and conditions of (i) that certain Intellectual Property Security Agreement dated as of August 29, 2018 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "IP Security Agreement") Grantor granted, assigned, conveyed, mortgaged, pledged, hypothecated and transferred to the Bank, and granted to the Bank, a security interest in all of such Grantor's right, title and interest in and to the trademarks listed on Schedule 1 attached hereto (the "Trademarks");

WHEREAS, the was recorded with the United States Patent and Trademark Office on August 30, 2018 at Reel/Frame 6431/0256;

WHEREAS, the Bank has consented to the release of the security interest in the Collateral listed on Schedule 1 attached hereto (collectively, the "Intellectual Property Collateral"); and

WHEREAS, the Bank desires to release its security interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby covenants and agrees as follows:


1. The Bank's security interest in the Intellectual Property Collateral granted pursuant to the IP Security Agreement is hereby terminated and released.

2. To the extent the Bank retains any such interest, the Bank hereby assigns, transfers and conveys to each Grantor, respectively, all of the Bank's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest in each of the Trademarks including, without limitation, the entire right, title and interest in and to each of the Trademarks, all renewals thereof, all proceeds of infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto and the goodwill of the business to which the Intellectual Property Collateral relates. Such assignment, transfer and conveyance by the Bank is made without any representation or warranty (express or implied) by the Bank.

3. The Bank hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of the Grantors. The Bank authorizes each Grantor (or their respective agents) to file such documentation as is necessary to effect the releases of the Intellectual Property Collateral granted hereunder.

IN WITNESS WHEREOF, the Bank has caused this Release to be executed by its duly authorized representative as of the Effective Date.
