INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT is dated as of November 5, 2019 ("*IP Security Agreement*"), is made by NEW NIXON HOLDINGS, INC., a Delaware corporation (the "*Company*"), NIXON MIDCO, INC., a Delaware corporation ("*Midco*"), NIXON BUYCO, INC., a Delaware corporation ("*Buyco*") and NIXON, INC., a California corporation ("*Nixon*", and with the Company, Midco, Buyco and Nixon each being a "*Grantor*" and collectively being the "*Grantors*"), in favor of MADRONE PARTNERS, L.P. ("*Secured Party*").

RECITALS

A. Secured Party has made and has agreed to make certain advances of money and to extend certain financial accommodations to Grantors as evidenced by that certain Secured Convertible Promissory Note dated November 5, 2019 executed by Grantors in favor of Secured Party (the "*Note*"), such advances, future advances, and financial accommodations being referred to herein as the "*Loans*". Any terms not otherwise specifically defined herein shall have the meanings set forth in the Security Agreement (defined below).

B. Secured Party is willing to make the Loans to Grantors, but only upon the condition, among others, that Grantors shall have granted Secured Party a security interest in certain Copyrights, Trademarks and Patents, whether presently existing or hereafter acquired, to secure the Secured Obligations by executing and delivering to Secured Party this IP Security Agreement, and the Security Agreement dated of even date herewith (as the same may be amended, modified or supplemented from time to time, the "*Security Agreement*").

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment of the Secured Obligations, each Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT

To secure its Secured Obligations under the Note and the Security Agreement, each Grantor hereby grants and pledges to Secured Party a security interest in all of each such Grantor's right, title and interest in, to and under its Intellectual Property (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C attached hereto), whether presently existing or hereafter acquired, and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.

This security interest is granted in conjunction with the security interest granted to Secured Party under the Security Agreement. The rights and remedies of Secured Party with respect to the security interest granted hereby are in addition to those set forth in the Security Agreement and the Note, and those which are now or hereafter available to Secured Party as a

matter of law or equity. Each right, power and remedy of Secured Party provided for herein or in the Security Agreement or in the Note, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Secured Party of any one or more of the rights, powers or remedies provided for in this IP Security Agreement, the Security Agreement or the Note, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Secured Party, of any or all other rights, powers or remedies.

Each Grantor represents and warrants that Exhibits A, B, and C attached hereto set forth any and all intellectual property rights in connection to which each such Grantor has registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office, as applicable.

This IP Security Agreement shall terminate automatically upon the payment in full (or conversion, as applicable) of the Secured Obligations and the expiration or termination of any commitment of Secured Party to make Loans to Grantors under the Note. Grantor agrees to promptly execute and deliver to Grantors any documentation and/or lien releases reasonably requested by Grantors to evidence the termination of the liens granted under this IP Security Agreement upon such repayment of the Secured Obligations at Grantors' cost.

In all respects, including all matters of construction, validity and performance, this Security Agreement shall be governed by, and construed and enforced in accordance with, the laws of the State of California applicable to contracts made and performed in such state, without regard to the principles thereof regarding conflict of laws, except to the extent that the UCC provides for the application of the law of a different jurisdiction.

Any assignment or transfer of this IP Security Agreement is governed by the assignment and transfer terms more specifically set forth in the Note and the Security Agreement.

This IP Security Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument.
