SECOND LIEN PATENT AND TRADEMARK SECURITY AGREEMENT dated as of November 6, 2019 (this “**Agreement**”), between DELUXE 3D LLC, a Delaware limited liability company, having an office at 2400 West Empire Avenue, Burbank, CA 91504, DELUXE ENTERTAINMENT SERVICES INC., a Delaware corporation, having an office at 2400 West Empire Avenue, Burbank, CA 91504, DELUXE MEDIA INC. (F/K/A DELUXE DIGITAL STUDIOS, INC.), a Delaware corporation, having an office at 2400 West Empire Avenue, Burbank, CA 91504, DELUXE CREATIVE SERVICES INC. (F/K/A DELUXE MEDIA CREATIVE SERVICES INC.), a Delaware corporation, having an office at 2400 West Empire Avenue, Burbank, CA 91504, SOFTTLER NET, INC., a California corporation, having an office at 2400 West Empire Avenue, Burbank, CA 91504, DELUXE ONE LLC (F/K/A DELUXE MEDIUSONE LLC), a Delaware limited liability company, having an office at 2400 West Empire Avenue, Burbank, CA 91504, and DELUXE LABORATORIES LLC, a Delaware limited liability company having an office at 2400 West Empire Avenue, Burbank, CA 91504, (each a “**Grantor**” and collectively the “**Grantors**”) and CORTLAND CAPITAL MARKET SERVICES LLC, a Delaware limited liability company having an office at 225 W. Washington St., 9<sup>th</sup> Floor, Chicago, IL 60606, in its capacity as administrative agent and collateral agent for certain Lenders (the “**Collateral Agent**”).

Reference is made to (a) the Second Lien Credit Agreement dated as of November 6, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “**Second Lien Credit Agreement**”), among DELUXE ENTERTAINMENT SERVICES INC., a Delaware corporation (the “**Borrower**”), DESG INTERMEDIATE II INC., a Delaware corporation (“**Holdings**”), the Lenders party thereto and CORTLAND CAPITAL MARKET SERVICES LLC, as Administrative Agent and Collateral Agent, and (b) the Second Lien Guarantee and Collateral Agreement dated as of November 6, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “**Second Lien Guarantee and Collateral Agreement**”), among the Borrower, Holdings, the Guarantors, Subsidiary Guarantors, Grantors and CORTLAND CAPITAL MARKET SERVICES LLC, as Collateral Agent. The Lenders have agreed to extend credit to the Borrower subject to the terms and conditions set forth in the Second Lien Credit Agreement. The obligations of the Lenders to extend such credit are conditioned upon, among other things, the execution and delivery of this Agreement. The Grantors, Holdings and the Guarantors party hereto are Affiliates of the Borrower, will derive substantial benefits from the extension of credit to the Borrower pursuant to the Second Lien Credit Agreement and are willing to execute and deliver this Agreement in order to induce the Lenders to extend such credit. Accordingly, the parties hereto agree as follows:

SECTION 1. **Terms.** Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Second Lien Guarantee and Collateral Agreement. The rules of construction specified in Section 1.2 of the Second Lien Guarantee and Collateral Agreement also apply to this Agreement.

SECTION 2. **Grant of Security Interest.** Each Grantor hereby grants to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in and to the following property now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "**Patent and Trademark Collateral**") as collateral security for the payment or performance, as the case may be (whether at the stated maturity, by acceleration or otherwise), of the Secured Obligations:

(i) all letters patent of the United States, all registrations and recordings thereof, and all applications for letters patent of the United States, including registrations, recordings and pending applications in the United States Patent and Trademark Office (or any successor office) ("PTO"), including those listed on Schedule I hereto, and all reissues, continuations, divisions, continuations in part, renewals or extensions thereof, and the inventions disclosed or claimed therein, including the right to make, use and/or sell the inventions disclosed or claimed therein; and

(ii) (a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, all registrations thereof, and all registration applications filed in connection therewith, including registrations and registration applications in the PTO, including registrations, recordings and pending applications in the PTO (or any successor office), and all extensions or renewals thereof, including, in the case of any Grantor, any of the foregoing set forth next to its name on Schedule II hereto and (b) all goodwill associated therewith or symbolized thereby, including any rights or interests that reflect or embody such goodwill.

provided, however, that the foregoing pledge assignment and grant of security interest will not cover any applications for any trademarks that have been filed with the PTO on the basis of an "intent-to-use" with respect to such trademarks until an appropriate amendment to allege use or statement of use is filed in and accepted by the PTO.

SECTION 3. **Collateral Agreement.** The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Second Lien Guarantee and Collateral Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Patent and Trademark Collateral are more fully set forth in the Second Lien Guarantee and Collateral Agreement, the terms and

provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Second Lien Guarantee and Collateral Agreement, the terms of the Second Lien Guarantee and Collateral Agreement shall govern.

**SECTION 4. Counterparts.** This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or other electronic imaging shall be effective as delivery of a manually executed counterpart of this Agreement.

**SECTION 5. Intercreditor Agreements.** Notwithstanding anything herein to the contrary, each of (i) the obligations of each Grantor under this Agreement, (ii) the lien and security interest granted to the Collateral Agent pursuant to this Agreement, (iii) the release of Collateral from the Lien granted and created hereby and (iv) the exercise of any right or remedy by Collateral Agent hereunder are, in each case, subject to the provisions of the Intercreditor Agreements (as defined in the Second Lien Credit Agreement). In the event of any conflict or inconsistency between the provisions of any of the Intercreditor Agreements and this Agreement, the provisions of the Intercreditor Agreements shall control.

**SECTION 6 Recordation.** Each of the Grantors hereby authorizes the Commissioners for Patents and Trademarks and any other related government officials to record and register this Agreement in connection with the Patent and Trademark Collateral.


