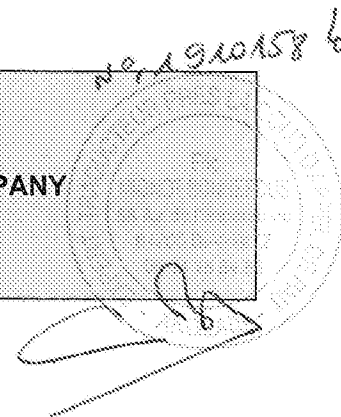

**DECLARATION OF DISSOLUTION
OF THE LANCÔME PARFUMS ET BEAUTE & CIE COMPANY
BY THE L'OREAL COMPANY**



I, the undersigned, Christophe BABULE,

Acting in the capacity of representative of L'OREAL (hereinafter referred to as "L'OREAL"), a *société anonyme* (limited company) with a capital of €112,079,330.40, whose registered office is at 14, rue Royale, 75008 Paris, registered in the Paris Trade and Companies Register under the number 632 012 100.

After having presented the following preamble:

PREAMBLE

LANCÔME PARFUMS ET BEAUTE & CIE is a general partnership company (*société en nom collectif*) with a capital of €1,191,750, whose registered office is at 14, rue Royale, 75008 Paris, and whose principal activity is the legal management of the LANCÔME trademark, its being responsible for its protection, filing and licensing.

It is registered in the Paris Trade and Companies Register under the number 302 387 196. On the date of this declaration, L'OREAL owns all the shares making up the share capital of **LANCÔME PARFUMS ET BEAUTE & CIE** of €1,191,750, namely 79,450 shares with a nominal value of 15 euros each.

Declare, this having been set out, that the following decisions have been taken:

1. EARLY DISSOLUTION

L'OREAL, the sole shareholder of LANCÔME PARFUMS ET BEAUTE & CIE:

- decides to dissolve, as from this day, LANCÔME PARFUMS ET BEAUTE & CIE in accordance with Article 1844-5 of the Civil Code,
- acknowledges that this dissolution, without liquidation, will take effect by the Complete Transfer of the Assets and Liabilities of LANCÔME PARFUMS ET BEAUTE & CIE to L'OREAL, either at the end of the timeframe in which creditors may lodge an objection provided for in Article 1844-5 of the Civil Code, namely thirty days as from the date of publication of the corresponding legal notice, or when any objections have been rejected in the first instance, or when the guarantees decided on judicially have been set in place.

2. METHOD OF ENTERING THE CONTRIBUTIONS IN THE ACCOUNTS

Regulation no. 2014-03 of 5 June 2014 of the Accounting Standards Authority stipulates that assets contributed on the occasion of a restructuring operation taking place between

two companies under common control must be valued at their net book value. In consequence, the assets and liabilities of LANCÔME PARFUMS ET BEAUTE & CIE will be taken over at this value in L'OREAL's accounting records.

3. TAX REGIME

L'OREAL declares:

- that it is placing the dissolution without liquidation operation under the preferential tax regime provided for in Article 210-A of the General Tax Code with regard to corporation tax,
- that it is making the said operation fiscally retroactive to 1 January 2019.

All operations carried out since 1 January 2019 by the dissolved company will; from a tax point of view, be deemed, with regard to both assets and liabilities, to have been carried out on behalf of L'OREAL.

In consequence, the options and undertakings relating to the dissolution without liquidation operation will be as follows:

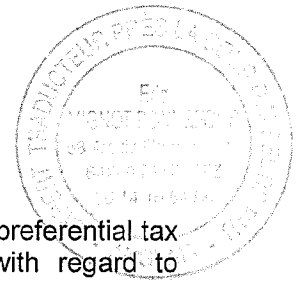
A. With regard to registration fees

The decision to dissolve the company will be registered free of charge in application of Article 811 of the General Tax Code¹, it being specified that the company's assets do not consist of property.

B. With regard to corporation tax

- a) To ensure that the dissolution without liquidation operation may benefit from the tax regime provided for in Article 210-A of the General Tax Code, L'OREAL undertakes, in particular, to comply with the provisions of Article 210-A-3 of the General Tax Code. In consequence, L'OREAL undertakes to:
 - i. take over among its liabilities provisions made by LANCÔME PARFUMS ET BEAUTE & CIE whose taxation has been deferred,
 - ii. substitute LANCÔME PARFUMS ET BEAUTE & CIE for the reintegration of profits whose taxation has been deferred,
 - iii. calculate, in respect of non-amortisable fixed assets and portfolio securities that are transferred to it whose disposal gains or losses are excluded from the long-term capital gains or losses regime, capital gains that are realised at a later date at the time of their sale or transfer, on the basis of their fiscal value in LANCÔME PARFUMS ET BEAUTE & CIE's accounts,
 - iv. reintegrate into its taxable profits, within the timeframes and in accordance with the conditions provided for in sub-paragraph d) of paragraph 3 of Article 210.A of the General Tax Code, any capital gains that may be realised in the context of the present operation in respect of amortisable assets transferred to it; this undertaking includes the obligation incumbent on L'OREAL by virtue of the provisions of the aforesaid Article 210 A-3-d to, in the case of transfer of one of

the amortisable assets transferred to it, immediately submit to taxation the portion of the capital gain realised on this asset which had not yet been reintegrated on the date of the said transfer,

- v. the dissolution without liquidation operation being recorded in L'OREAL's accounts on the basis of the book values, take over in its balance sheet accounting entries in LANCÔME PARFUMS ET BEAUTE & CIE's accounts relating to fixed assets and portfolio securities whose disposal gains or losses are excluded from the long-term capital gains or losses regime (original value, amortisations, provisions for depreciation) and continue to calculate the depreciation and amortisation expenses on the basis of the original values that the said assets had in LANCÔME PARFUMS ET BEAUTE & CIE's accounts,
 - vi. enter in its balance sheet items other than the fixed assets included in the Complete Transfer of Assets and Liabilities at the fiscal value that these items had in LANCÔME PARFUMS ET BEAUTE & CIE's accounts, or failing this incorporate into the taxable profit or loss for the financial year of the operation the profit corresponding to the difference between the book value of assets other than fixed assets and their fiscal value in LANCÔME PARFUMS ET BEAUTE & CIE's accounts.
- b) L'OREAL undertakes to enclose with its annual tax return a statement conforming to the template supplied by the authorities providing, for each type of asset transferred by LANCÔME PARFUMS ET BEAUTE & CIE, the information necessary for calculation of the taxable profit that will be made in the future when the assets in question are transferred, in accordance with Article 54 *septies* I and Article 38 *quindecies* of Appendix III of the General Tax Code.

L'OREAL will enter the capital gains realised on non-amortised assets transferred by LANCÔME PARFUMS ET BEAUTE & CIE whose taxation has been deferred in the register provided for in Article 54 *septies* II of the General Tax Code.

L'OREAL, in its position of beneficiary company taking over the rights and obligations of the dissolved company, also undertakes to produce this statement on behalf of LANCÔME PARFUMS ET BEAUTE & CIE, within a timeframe of sixty days as from the cessation of the latter's business activities².

C. With regard to valued added tax

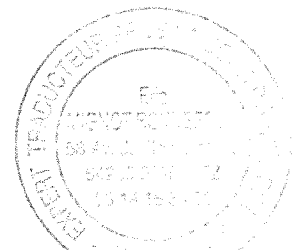
As LANCÔME PARFUMS ET BEAUTE & CIE and L'OREAL are both subject to VAT, the dissolution without liquidation will *ipso jure* be placed under the VAT dispensation regime provided for in Article 257 bis of the General Tax Code.

L'OREAL will carry out all the deduction regularisations which LANCÔME PARFUMS ET BEAUTE & CIE would have done if it had continued to legally exist.

L'OREAL being wholly subrogated in the rights and obligations of LANCÔME PARFUMS ET BEAUTE & CIE owing to the dissolution without liquidation, the VAT credit held by LANCÔME PARFUMS ET BEAUTE & CIE on the date on which it ceases to legally exist will be transferred to L'OREAL.

D. With regard to the Territorial Economic Contribution (CET)

LANCÔME PARFUMS ET BEAUTE & CIE will remain liable to pay the CFE on the score of the 2019 financial year, for the establishments that it operated on 1 January 2019.

LANCÔME PARFUMS ET BEAUTE & CIE will remain liable to pay the business tax on added value (CVAE) on the score of 2019 in respect of the added value created since the beginning of the current financial year on the date of the transfer of its assets and liabilities, independently of the retroactive effect provided for with regard to corporation tax.

4. FORMALITIES

L'OREAL will complete all the legal formalities resulting from this declaration for the purpose of recording:

- either that at the end of the timeframe of thirty days as from the publication of the notice of dissolution, no creditors have lodged an objection to the dissolution of LANCÔME PARFUMS ET BEAUTE & CIE,
- or if objections have been lodged within the aforesaid timeframe, these objections have been rejected in the first instance or the claims have been paid or guarantees have been set in place,
- in such a manner that LANCÔME PARFUMS ET BEAUTE & CIE is removed from the Paris Trade and Companies Register.

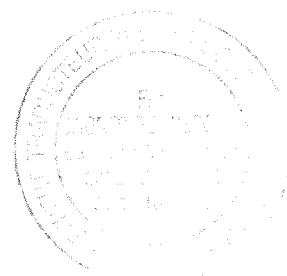


