#### TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of October 17, 2019, is made by each of the entities listed on the signature pages hereof (each a "Grantor" and, collectively, the "Grantors"), in favor of PNC BANK, NATIONAL ASSOCIATION, as administrative agent and collateral agent (in such capacity, together with its successors and permitted assigns, "Agent") for the Secured Parties (as defined in the Credit Agreement referred to below).

#### WITNESSETH:

WHEREAS, pursuant to the Revolving Credit Agreement, dated as of October 17, 2019 (as amended, restated or supplemented from time to time, the "Credit Agreement"), by and among BUTION HOLDCO 2, INC., a Delaware corporation ("Company 1") and BUTION HOLDCO 3, INC., a Delaware corporation ("Company 2"), and effective upon the consummation of the Closing Date Acquisition, NESTOR HOLDING COMPANY, a Delaware corporation ("Nestor"), LABEL INDUSTRIES, INC., a Missouri corporation ("Label"), LIBERTY BELL EQUIPMENT CORPORATION, a Pennsylvania corporation ("Liberty"), NESTOR SALES HOLDCO, LLC, a Delaware limited liability company ("Nestor Sales Holdco"), NESTOR SALES LLC, a Georgia limited liability company ("Nestor Sales"), ESSENDANT INDUSTRIAL LLC, an Illinois limited liability company ("Essendant"), TRANSSUPPLY GROUP, LLC, an Illinois limited liability company ("Transsupply Group"), O.K.I. SUPPLY LLC, an Illinois limited liability company ("O.K.I.", and together with Company 1, Company 2, Nestor, Label, Liberty, Nestor Sales Holdco, Nestor Sales, Essendant and Transsupply Group, collectively, the "Borrowers"), BUTION HOLDCO 1, LLC, a Delaware limited liability company, the lenders identified on the signature pages thereof or which hereafter become a party thereto in accordance with the terms thereof (each of such lenders, together with its successors and permitted assigns, is referred to hereinafter as a "Lender", as that term is further defined in Section 12.02 of the Loan Agreement) and PNC BANK, NATIONAL ASSOCIATION, as administrative agent for the Lenders, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, each Grantor (other than the Borrowers) has agreed, pursuant to a Guaranty and Security Agreement, dated as of October 17, 2019, in favor of Agent (as amended, restated or supplemented from time to time, the "Guaranty and Security Agreement"), to guarantee the Obligations (as defined in the Credit Agreement); and

WHEREAS, all of Grantors are party to the Guaranty and Security Agreement pursuant to which the Grantors party hereto are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce Agent and the Lenders to enter into the Credit Agreement and to induce the Lenders to make their respective extensions of credit to the Borrowers thereunder, each Grantor hereby agrees with Agent as follows:

**Section 1. Defined Terms**. Capitalized terms used herein without definition are used as defined in the Guaranty and Security Agreement.

Section 2. Grant of Security Interest in Trademark Collateral. Each Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of such Grantor, hereby mortgages, pledges and hypothecates to Agent for the benefit of the Secured Parties, and grants to Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor (the "Trademark Collateral"):

- (a) all of its Trademarks and all of its IP Licenses granting rights under Trademarks, including, without limitation, those referred to on Schedule 1 hereto;
  - (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.
- Section 3. Guaranty and Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to Agent pursuant to the Guaranty and Security Agreement and each Grantor hereby acknowledges and agrees that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Guaranty and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
- Section 4. Grantor Remains Liable. Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with their Trademarks and IP Licenses subject to a security interest hereunder, in each case to the extent required pursuant to the express terms of the Guaranty and Security Agreement.
- **Section 5. Counterparts.** This Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.
- Section 6. Governing Law. This Trademark Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
