RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of November 21, 2019 (the “Effective Date”), is made by Bank of America, N.A., in its capacity as Collateral Agent (the “Agent”), in favor of the grantor parties identified on the signature pages hereto (collectively, the “Grantors”).

WHEREAS, pursuant to that certain Security Agreement dated as of April 30, 2012 by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered an Intellectual Property Security Agreement, dated as of April 30, 2012, a Supplement No. 1, dated as of May 20, 2014 to the Amended and Restated Intellectual Property Security Agreement dated as of March 28, 2013, and a Supplement No. 2, dated as of October 17, 2014, to the Amended and Restated Intellectual Property Security Agreement dated as of March 28, 2013 (collectively, as amended, amended and restated, supplemented or otherwise modified from time to time, the “Intellectual Property Security Agreements”), for recordal with the United States Patent and Trademark Office; and

WHEREAS, the above referenced Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on May 7, 2012 at Reel/Frame 004774/0301, the above reference Supplement No. 1 to the Amended and Restated Intellectual Property Agreement was recorded with the United States Patent and Trademark Office on October 10, 2014 at Reel/Frame 005379/0335, and the above referenced Supplement No. 2 to the Amended and Restated Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on October 17, 2014 at Reel/Frame 005383/0332.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Intellectual Property Security Agreements, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Intellectual Property Collateral, including the trademark registrations and applications set forth on Schedule I attached hereto, arising under the Security Agreement and the Intellectual Property Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Intellectual Property Collateral under the Intellectual Property Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Intellectual Property Security Agreements.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably


requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.


