RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS

This RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of December 2, 2019, by ANTARES CAPITAL LP, as First Lien Collateral Agent (in such capacity, the “**First Lien Collateral Agent**”), in favor of LIAISON INTERNATIONAL LLC and ACADEMIC SOFTWARE PLUS, LLC (each, a “**Grantor**”). Capitalized terms used but not defined herein have the meanings given to them (including by reference) in the Collateral Agreement (as defined below).

WHEREAS, the Grantors and the First Lien Collateral Agent are party to (i) that certain First Lien Collateral Agreement, dated as of February 8, 2017 (as amended, supplemented or otherwise modified from time to time, the “**Collateral Agreement**”), and (ii) that certain First Lien Trademark Security Agreement, dated as of February 8, 2017 (the “**Trademark Security Agreement**”), whereby each Grantor granted to the First Lien Collateral Agent, for the benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in, to and under the Trademarks listed on Schedule I attached hereto, including all goodwill associated therewith or symbolized thereby, all registrations thereof and applications for the registration thereof in the United States Patent and Trademark Office, and all rights to sue or otherwise recover for any past, present and future infringement, dilution, or other violation or impairment thereof, including the right to receive all Proceeds therefrom, including without limitation license fees, royalties, income payments, claims, damages and proceeds of suit, now or hereafter due and/or payable with respect thereto, and all other rights, priorities, and privileges accruing thereunder or pertaining thereto throughout the world (the “**Trademark Collateral**”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 9, 2017 at Reel/Frame 5988/0919 (Liaison) and at Reel/Frame 5986/0904 (Academic); and


WHEREAS, the Grantors have requested that the First Lien Collateral Agent execute and deliver this Release to evidence the release of its security interest in the Trademark Collateral for filing and recordation with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the First Lien Collateral Agent (on behalf of itself and the other Secured Parties), without any representation, warranty or recourse of any kind or nature, hereby releases and terminates its security interest in the Trademark Collateral, and re-assigns and re-conveys to the Grantors (as applicable) any and all right, title or interest the First Lien Collateral Agent may have in or to the Trademark Collateral.
