**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Agreement") is effective as of November 13, 2019 (the "Effective Date"), by and between Loggly Inc., a Delaware corporation ("Assignor") and SolarWinds Worldwide, LLC, a Delaware limited liability company ("Assignee").

**WITNESSETH:**

WHEREAS, Assignee is sole shareholder of Assignor;

WHEREAS, the board of directors of Assignee and Assignor in its capacity as the sole shareholder of Assignee have approved the liquidation, winding up and distribution of the assets of the Assignee pursuant to a Plan of Liquidation and Distribution dated November 13, 2019 (the "Plan of Liquidation");

WHEREAS, the Plan of Liquidation provides for the transfer of Assignor's assets to Assignee;

WHEREAS, Assignor and Assignee have agreed to enter into this Agreement as further evidence of the transfer of Assignor's assets, including the specific trademarks, copyrights, patents, and domain names listed on Schedule A (the "Intellectual Property") to Assignee;

NOW, THEREFORE, in accordance with the Plan of Liquidation and Section 281(b) of the Delaware General Corporation Law, the parties hereby agree as follows:

1. Assignor hereby irrevocably assigns, transfers and conveys to Assignee, absolutely and in perpetuity, all of Assignor's entire right, title, and interest in and to the Intellectual Property worldwide, together with all of the goodwill associated therewith, and including the right to sue for and receive all damages from past infringements arising prior to the Effective Date, the same to be held and enjoyed by Assignee, its successors and assigns.

2. Assignor agrees to take all actions reasonably requested by Assignee to convey the Intellectual Property from Assignor to Assignee.

IN WITNESS WHEREOF, Assignor caused this Agreement to be executed by its duly authorized representatives as of the Effective Date.
