**TRADEMARK, PATENT, COPYRIGHT AND DESIGN PATENT CONFIRMATORY
ASSIGNMENT AGREEMENT**

This **TRADEMARK, PATENT, COPYRIGHT AND DESIGN PATENT CONFIRMATORY ASSIGNMENT AGREEMENT** (this “*Agreement*”) dated and effective as of November 1, 2019 (the “*Effective Date*”), is entered into by and between:

(1) Bayer Consumer Care Holdings LLC, a limited liability company formed under the laws of Delaware, having its business address at 100 Bayer Boulevard, Whippany, New Jersey 07981 (f/k/a MSD Consumer Care, Inc.) (“*BCCH*”);

(2) Bayer Consumer Care AG, a corporation incorporated under the laws of Switzerland, having its business address at Peter-Merian-Street 84, 4052 Basel, Switzerland (“*BCC AG*”);

(3) Bayer HealthCare LLC, a limited liability company under the laws of the United States, having its business address at 100 Bayer Boulevard, Whippany, NJ 07981 (collectively with BCC AG and BCCH, the “*Assignors*”); and

(4) DRS Acquisition LLC, a limited liability company incorporated under the laws of Delaware, having its business address at 255 State St, Boston, MA 02109 (“*Assignee*”).

Assignors and Assignee are collectively referred to as the “*Parties*” and individually referred to as a “*Party*.” Capitalized terms not defined herein have the definitions set forth in the IP Agreement (as defined below).

WHEREAS, in connection with the transactions contemplated by (a) that certain Asset Purchase Agreement entered into between Bayer Aktiengesellschaft (“*BAG*”) and Assignee, dated as of July 19, 2019 (as amended by that certain Side Letter to Asset Purchase Agreement dated as of October 18, 2019, and as further amended by that certain Amendment and Waiver to Asset Purchase Agreement dated as of October 31, 2019 and as may be further amended, restated, supplemented or otherwise modified, the “*Asset Purchase Agreement*”) and (b) that certain Trademark, Patent, Copyright and Design Patent Assignment (as amended, restated, supplemented or otherwise modified, the “*IP Assignment*”), dated November 1, 2019, on the terms and subject to the conditions set forth herein, Assignors desire to sell, assign, transfer, convey and deliver to Assignee, and Assignee desires to acquire, all rights, title, and interest that Assignors may hold in and to (a) the Trademarks set forth on Schedule A-1 attached hereto (collectively, the “*Assigned Trademarks*”), (b) the Patents set forth on Schedule A-2 attached hereto and to the inventions and discoveries covered by each of the foregoing (collectively, the “*Assigned Patents*”), (c) the Design Patents set forth on Schedule A-3 attached hereto (the “*Assigned Design Patents*”), and (d) the Copyrights set forth on Schedule A-4 attached here to (the “*Assigned Copyrights*”; the Assigned Trademarks, Assigned Patents, Assigned Design Patents and Assigned Copyrights are collectively referred to as, the “*Assigned Registered IP Rights*”).

NOW, THEREFORE, in consideration of the foregoing, the mutual agreements and covenants set forth in the Asset Purchase Agreement and the IP Assignment, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

Section 1. Assignment of Assigned Trademarks. Effective as of the Effective Date of the IP Agreement, Assignors sold, assigned, transferred, conveyed and delivered to Assignee, and Assignee accepted, all of Assignors' rights, title and interests in and to the Assigned Trademarks, including (a) all priority rights and rights under the International Convention for the Protection of Industrial Property associated with any of the Assigned Trademarks, (b) all rights to bring an Action, whether at law or in equity, for infringement or other violation of any of the Assigned Trademarks against any Person, and all rights to recover damages, profits, injunctive relief and other relief for all past, present or future infringement or other violation of any of the Assigned Trademarks and (c) all goodwill of the business associated with and symbolized by any of the Assigned Trademarks. The foregoing assignment with respect to any U.S. intent-to-use application included in the Assignment Trademarks (collectively, the "Assigned ITU Marks") is being made to Assignee, as successor to that portion of Assignors' business to which such Assigned ITU Marks pertains, which business is existing and ongoing.

Section 2. Assignment of Assigned Patents. Effective as of the Effective Date of the IP Assignment, Assignors sold, assigned, transferred and set over to Assignee, and Assignee accepted, all of Assignors' rights, title and interests in and to the Assigned Patents, including (a) all original, divisional, continuation, continuation-in-part, substitute, reissue, reexaminations and extensions of said Assigned Patents and all Patents applied for or granted based on any of the Assigned Patents, in any country, (b) all priority rights and rights under the International Convention for the Protection of Industrial Property associated with any of the Assigned Patents and (c) all rights to bring an Action, whether at law or in equity, for infringement or other violation of any of the Assigned Patents against any Person, and all rights to recover damages, profits, injunctive relief and other relief for all past, present or future infringement or other violation of any of the Assigned Patents.

Section 3. Assignment of Assigned Design Patents. Effective as of the Effective Date of the IP Assignment, Assignors sold, assigned, transferred, conveyed and delivered to Assignee, and Assignee accepted, all of Assignors' rights, title and interests in and to the Assigned Design Patents, including (a) all priority rights and rights under the International Convention for the Protection of Industrial Property associated with any of the Assigned Design Patents and (b) all rights to bring an Action, whether at law or in equity, for infringement or other violation of any of the Assigned Design Patents against any Person, and all rights to recover damages, profits, injunctive relief and other relief for all past, present or future infringement or other violation of any of the Assigned Design Patents.

Section 4. Assignment of Assigned Copyrights. Effective as of the Effective Date of the IP Agreement, Assignors sold, assigned, transferred, conveyed and delivered to Assignee, and Assignee accepted, all of Assignors' rights, title and interests in and to the Assigned Copyrights, including (a) all rights to bring an Action, whether at law or in equity, for infringement or other violation of any of the Assigned Copyrights against any Person, and (b) all rights to recover damages, profits, injunctive relief and other relief for all past, present or future infringement or other violation of any of the Assigned Copyrights.

Section 5. Authorization. Assignors hereby authorize and request the competent officer at the German Patent and Trademark Office (*Deutsches Patent und Markenamt*), the U.S. Patent and Trademark Office, the U.S. Copyright Office and any corresponding official of any other

jurisdiction or organization whose duty it is to issue patents, trademark registrations or registered design rights to record this Agreement and record Assignee as the assignee of all of the applicable Assignors' right, title and interest in and to the Assigned Trademarks, Assigned Patents, Assigned Copyrights and Assigned Design Patents, as applicable, in the appropriate jurisdiction and to deliver to Assignee, and to Assignee's attorneys, agents, successors or assigns, all official documents and communications with respect to any such Assigned Trademarks, Assigned Patents, Assigned Copyrights and Assigned Design Patents. The Parties hereby acknowledge and affirm that their respective rights in and to the Assigned Trademarks, Assigned Patents, Assigned Copyrights and Assigned Design Patents are more fully set forth in the Asset Purchase Agreement and the IP Agreement. In the event of any conflict between the terms of this Agreement and the terms of the Asset Purchase Agreement or the IP Agreement, the terms of the Asset Purchase Agreement or the IP Agreement, as applicable, shall control.

Section 6. Severability. Any term or provision of this Agreement that is invalid or unenforceable in any situation in any jurisdiction shall not affect the validity or enforceability of the remaining terms and provisions hereof or the validity or enforceability of the offending term or provision in any other situation or in any other jurisdiction. Any provision of this Agreement held invalid or unenforceable only in part or degree will remain in full force and effect to the extent not held invalid or unenforceable.

Section 7. Governing Law and Venue. This Agreement shall be governed by and construed in accordance with the domestic Laws of the State of Delaware without giving effect to any choice or conflict of Law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the Laws of any jurisdiction other than the State of Delaware.




