INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (this “**Assignment**”), effective as of December 20, 2019 (the “**Effective Date**”), is by and between Lamons Gasket Company, a Delaware corporation (“**Asset Seller**”), Lamons Belgium BVBA, a private company with limited liability (besloten vennootschap met beperkte aansprakelijkheid) incorporated under the laws of Belgium (“**Lamons Belgium**”), Lamons (Thailand) Co. Ltd., a private limited company incorporated under the laws of Thailand (“**Lamons Thailand**”), Lamons Singapore Pte. Ltd., a private limited company incorporated under the laws of Singapore (“**Lamons Singapore**”), Lamons Canada Limited, a corporation incorporated under the laws of Canada (“**Lamons Canada**”), Lamons Gasket and Bolt Ibérica, S.L., a company organized under the laws of Spain (“**Lamons Spain**,” collectively with Lamons Belgium, Lamons Thailand, Lamons Singapore, and Lamons Canada, the “**Divested Companies**,” and collectively with Asset Seller, the “**Assignors**”), and LGC US Asset Holdings, LLC, a Delaware limited liability company (“**Assignee**”). Each of the parties is referred to individually as a “**Party**,” and collectively as the “**Parties**.”

Assignee, along with Trimas Company LLC, LGC US Finco, LLC, and Trimas Corporation, have entered into an Asset and Stock Purchase Agreement, dated November 1, 2019 (the “**Purchase Agreement**”), pursuant to which Trimas Company LLC has agreed to cause the Asset Seller to assign to Assignee all worldwide rights in Acquired Intellectual Property (as defined below), including the patents and patent applications set forth in Attachment A (the “**Patents**”) and the registered trademarks and trademark applications set forth in Attachment B (the “**Trademarks**”).

In consideration of the promises and covenants set forth in this Assignment and in the Purchase Agreement, the Parties agree as follows:

1. Definitions. Capitalized terms used but not defined herein or below shall have the meanings ascribed to such terms in the Purchase Agreement:

(a) “**Acquired Intellectual Property**” means all Intellectual Property owned by the Divested Companies, and all Intellectual Property owned by the Asset Seller, and the right to sue, and collect damages for, past, present or future, infringement, dilution or other violation of the foregoing.

(b) “**Intellectual Property**” means any and all proprietary, industrial and intellectual property rights, under the law of any jurisdiction or rights under international treaties, both statutory and common law rights, including (i) patents, patent applications, and invention disclosures, worldwide, together with reissuances, continuations, continuations-in-part, divisions, supplementary protection certificates, extensions and re-examinations thereof, (ii) registered and unregistered trademarks, trade names, trade dress, service marks, brand names, logos, Internet domain names and other indicia of source, worldwide, and registrations and applications for registration thereof, and their associated

goodwill, (iii) copyrights and copyrightable works (including software, databases and related items) and all other rights of authorship recognized by statute or otherwise, and all applications, registrations and renewals in connection therewith, (iv) trade secrets and rights in other proprietary or confidential information, including inventions, improvements thereto, technical information, processes, formulae, technology, discoveries, know-how, specifications, designs, plans, manuals, drawings, research, computer programs, marketing studies, customer lists, and (v) all other intellectual property and moral rights, and all registrations and applications for any of the foregoing.

2. Assignment. Assignors hereby, absolutely and unconditionally, conveys, sells, assigns, transfers, grants and sets over unto the Assignee, all of the Assignors' right, title and interest and benefit in and to the Acquired Intellectual Property, including the Patents and Trademarks, together with the right to all past, present and future income, royalties, damages and payments due with respect to the foregoing and all rights of action, both at law and in equity with respect thereto, including all rights to sue, settle any claim, and collect all damages for any past, present, or future infringement or misappropriation of the Acquired Intellectual Property (including the Patents and Trademarks), including the goodwill of the businesses connected to the use of any of the Acquired Intellectual Property, in all cases free and clear of all Encumbrances, the same to be held and enjoyed by the Assignee, its successors and assigns forever, as fully and entirely as the same could have been held and enjoyed by the Assignors if this assignment had not been made and the Assignee does hereby accept such sale, assignment, transfer, grant, conveyance and set over.

3. Absolute Conveyance. The conveyance of the Acquired Intellectual Property (including the Patents and Trademarks) hereunder is an absolute transfer to Assignee.

4. Further Assurances. After the Effective Date, the Parties shall execute and deliver such other certificates, agreements, conveyances and other documents, and take such other action, as may be reasonably requested by the other Party in order to complete the sale, assignment, transfer and conveyance to Assignee of all of the right, title and interest of Assignors in, to and under the Acquired Intellectual Property (including the Patents and Trademarks) hereby sold, assigned, transferred or conveyed, or intended so to be. The Assignors hereby covenant and agree that, at Assignee's expense, the Assignors shall sign all lawful papers, execute all applications (including, but not limited to, powers of attorney, specific assignments, transfers and assurances), make all rightful oaths and use reasonable best efforts at the request of the Assignee to aid the Assignee, its successors, legal representatives and assigns in obtaining and enforcing protection for the Acquired Intellectual Property, including using commercially reasonable efforts to testify (or, as applicable, assisting in obtaining testimony from individuals associated with the development or creation of Acquired Intellectual Property) in legal proceedings involving the Acquired Intellectual Property. In the event the Assignee is unable, after reasonable effort, to secure a signature on any document reasonably necessary or appropriate for any of the foregoing purposes, then the

applicable Assignor hereby constitutes and appoints the Assignee the true and lawful attorney of such Assignor to act as such Assignor's attorney-in-fact solely for the purpose of executing any such documents and to do other lawfully permitted acts to further the prosecution and issuance of any Patents, Trademarks and other analogous protections with the same legal force and effect as if executed by such Assignor.

5. Recordation. Assignors authorize and request the U.S. Patent and Trademark Office and any foreign equivalent thereto, and any other governmental body or authority to record Assignee, including any of its successors and designees, as owner of the Acquired Intellectual Property (including the Patents and Trademarks) and of the entire title and interest in, to and under the same, for the use and enjoyment of the Acquired Intellectual Property (including the Patents and Trademarks) by Assignee, its successors, assigns and other legal representatives.

6. Purchase Agreement. This Agreement is delivered pursuant to the Purchase Agreement, and is subject to all of the representations, warranties, covenants and agreements set forth in the Purchase Agreement. In the event of any inconsistency between the terms of this Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall govern and shall supersede this Assignment in all respects.

7. No Third Party Beneficiaries. Nothing in this Assignment, express or implied, is intended or shall be construed to confer upon, or give to, any person other than the Parties any remedy or claim under or by reason of this Assignment or any agreements, terms, covenants or conditions hereof, and all the agreements, terms, covenants and conditions in this Assignment shall be for the sole and exclusive benefit of the Parties and their respective successors and permitted assigns.

8. Binding Effect; Assignment. All of the covenants, terms and conditions set forth herein shall be binding upon and shall inure to the benefit of the Parties and their respective successors and assigns.

9. Governing Law. THIS ASSIGNMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF DELAWARE (WITHOUT REGARD TO ANY APPLICABLE CONFLICTS OF LAW PRINCIPLES THEREOF).






