This RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of January 17, 2020 (this “Release”), is made by CITIBANK, N.A. (“Citibank”), as the collateral agent for the Non-Notes Secured Parties (in such capacity, the “Collateral Agent”), in favor of Grantors (as defined below).

A. Reference is made to (i) the Guarantee and Collateral Agreement, dated as of August 16, 2016 (as supplemented by Supplement No. 1, dated August 16, 2016 and as further supplemented by Supplement No. 2, dated November 17, 2017 and as further amended, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among Leidos Holdings, Inc., a Delaware corporation (“Holdings”), Leidos, Inc., a Delaware corporation (the “Borrower”), the Guarantors from time to time party thereto, and Citibank, as Non-Notes Secured Parties Collateral Agent; (ii) the Credit Agreement, dated as of August 16, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among Holdings, the Borrower (as successor borrower to Leidos Innovations Corporation (f/k/a Abacus Innovations Corporation)), the Lenders from time to time party thereto and Citibank, as Administrative Agent and as collateral agent; and (iii) the Trademark Security Agreement dated as of August 16, 2016 by and between Varec, Inc., a Georgia corporation, Reveal Imaging Technologies, Inc., a Delaware corporation, R.W. Beck Group, Inc., a Washington corporation, Leidos Innovations Technology, Inc. (f/k/a Abacus Innovations Technology, Inc.), a Delaware corporation, OAO Corporation, a Maryland corporation, QTC Management, Inc., a California corporation, Systems Made Simple, Inc., a New York corporation, Leidos Cyber, Inc. (f/k/a Lockheed Martin Industrial Defender, Inc.), a Delaware corporation and Sytex Inc., a Pennsylvania corporation (each a “Grantor” and together the “Grantors”) in favor of the Collateral Agent (the “Trademark Collateral Agreement”, and together with the Collateral Agreement, the “Security Agreements”).

B. Pursuant to the Security Agreements, the Grantors assigned, pledged and granted to the Collateral Agent, its successors and assigns, for the benefit of the Non-Notes Secured Parties, a security interest in, all right, title and interest of the Grantors in, to and under, among other things, the Trademark Collateral (as defined in the Trademark Collateral Agreement), including the Trademarks set forth in Schedule I hereto (together with all goodwill associated therewith or symbolized thereby and all other assets, rights and interests that uniquely reflect or embody such goodwill), and pursuant to the Trademark Collateral Agreement, such security interest was recorded with the United States Patent & Trademark Office (the “USPTO”) on August 24, 2016 at Reel/Frame 05863/0161.

C. Pursuant to the TLA/TLB Payoff Letter dated as of January 17, 2020, the Collateral Agent has agreed to release all right, title and interest granted to it, for the benefit of the Non-Notes Secured Parties, under the Security Agreements in and to the Trademark Collateral.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of the Non-Notes Secured Parties, does hereby state as follows:

SECTION 1. Terms. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Credit Agreement, the Collateral Agreement or the Trademark Collateral Agreement, as applicable.

SECTION 2. Release. The Collateral Agent, on behalf of itself, the Non-Notes Secured Parties and their permitted successors and assigns, hereby (i) terminates the Trademark Collateral Agreement, (ii) releases, relinquishes and fully discharges its and their lien and security interest granted under the Security Agreements in the Trademark Collateral (including the Trademarks set forth in Schedule I hereto) and (iii) assigns, transfers and conveys to the applicable Grantor and its successors and assigns any and all right, title and interest it may have in the Trademark Collateral (including the Trademarks set forth in Schedule I hereto). Any right, title or interest in the Trademark Collateral (including the Trademarks set forth in Schedule I hereto) granted under the Security Agreements to the Collateral Agent, on behalf of itself, the Non-Notes Secured Parties and their permitted successors and assigns shall hereby cease and become void. This Release is made without representation or warranty by, or recourse to, the Collateral Agent, or any other Non-Notes Secured Party.

SECTION 3. Further Assurances. The Collateral Agent hereby authorizes each Grantor or such Grantor's designated representative to record this Release with the USPTO or any other applicable governmental office or registrar. The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect and record the release of the security interest contemplated hereby, solely at the cost of Borrower and Holdings.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
