RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of January 23, 2020 is made by Bank of Montreal (the "Existing Lender") in favor of Nygard Inc., a Delaware corporation (the "Pledgor"). WHEREAS, pursuant to that (i) certain Credit Agreement, dated as of May 4, 2017 (as amended, restated, supplemented, waived or otherwise modified, the "Credit Agreement"), among Nygard International Partnership, a Manitoba partnership, the Pledgor, the other guarantors party thereto and the Existing Lender, (ii) certain Pledge, Guaranty and Security Agreement, dated as of May 4, 2017 (as amended, restated, supplemented, waived or otherwise modified, the "Security Agreement"), among the Pledgor, the other grantors party thereto and the Existing Lender, and (iii) certain Grant of a Security Interest -- Trademarks, dated as of May 4, 2017 (the "Trademark Security Agreement"), executed by the Pledgor in favor of the Existing Lender, the Pledgor pledged and granted to the Existing Lender a security interest in and continuing lien on all of the Pledgor's right, title and interest in, to and under the Trademarks listed on Schedule 1 attached hereto (the "Trademark Collateral"); and

WHEREAS, the security interest in the Trademark Collateral pledged and granted by the Pledgor to the Existing Lender under the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on May 9, 2017, at Reel 006052, and Frame 0894; and

WHEREAS, the Existing Lender has agreed to terminate, release and discharge its security interest and lien on all of the Trademark Collateral; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Existing Lender hereby agrees as follows:

- 1. The Existing Lender hereby releases and discharges all of its mortgages, liens and security interests in all of the Pledgor's right, title and interest in, to and under the Trademark Collateral, which had been granted under the Trademark Security Agreement and hereby reassigns any and all such right, title and interest (if any) that the Existing Lender may have in the Trademark Collateral to the Pledgor.
- 2. The Existing Lender authorizes and requests that the United States Commissioner for Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.
