Assignor shall provide Assignee, its successors and assigns or other legal representatives, reasonable cooperation and assistance at Assignee's request and at Assignee's reasonable expense (including the execution and delivery of any and all affidavits, declarations, oaths, assignments, powers of attorney or other documentation as may be reasonably required) in the preparation and prosecution of any applications covering the VANGUARD trademark assigned herein; in the prosecution or defense of any opposition, infringement or other proceedings that may arise in

connection with any of the trademark rights assigned herein, including testifying as to any facts relating to the rights assigned herein and this Assignment; in obtaining any additional protection pertaining to the VANGUARD trademark that Assignee may deem appropriate which may be secured under the laws now or hereafter in effect in the United States or any other country; and in the implementation or perfection of this Agreement.

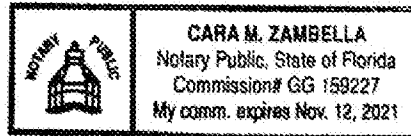
