**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS (the "Termination and Release"), effective as of the date of the last signature below (the "Effective Date"), from Derrick Lee Longson, an individual with an address at 189 N. Red Slide Circle, Wellsville, Utah 84339 ("Longson"), to North Atlantic Imports, LLC, a Utah limited liability company with an address at 513 West 2500 North, Logan, Utah 84341 ("NAI").

WHEREAS, NAI and Longson entered into (a) that certain Security Agreement, dated as of September 8, 2018, among Longson and NAI (the "Security Agreement") and (b) that certain Intellectual Property Security Agreement, dated as of September 8, 2018, among Longson and NAI (collectively, the "Intellectual Property Security Agreement"), pursuant to which NAI granted Longson a security interest (the "Security Interest") in certain Collateral (as defined in the Security Agreement), including, without limitation, the patents and trademarks identified on Schedule A hereto (the "Intellectual Property");

WHEREAS, the Security Interest was recorded in the Patent Division of the United States Patent and Trademark Office on September 10, 2018, at Reel 46830 and Frame 0099, in the form of the Intellectual Property Security Agreement;

WHEREAS, the Security Interest was also recorded in the Trademark Division of the United States Patent and Trademark Office on September 10, 2018, at Reel 6433 and Frame 0972, in the form of the Intellectual Property Security Agreement; and

WHEREAS, Longson now desires to terminate and release the entirety of his Security Interest in the Collateral, including, without limitation, the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Intellectual Property pursuant to the Security Agreement and the Intellectual Property Security Agreement (collectively, the "Agreements"), the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Longson hereby states as follows:

1. Release of Security Interest. As of the Effective Date, Longson hereby terminates, releases, and discharges his Security Interest in all of NAI's right, title, and interest of every kind and nature in the Collateral, including, without limitation, the Intellectual Property, and any right, title, or interest of Longson in the Collateral, including, without limitation, the Intellectual Property, hereby ceases and becomes void.


2. Assignment. Longson hereby covenants, represents and warrants that he has not sold, assigned, transferred, hypothecated, pledged, encumbered, or otherwise disposed of, in whole or in part, voluntarily or involuntarily, any of his right, title, or interest in and to the Agreements, the Collateral, the Intellectual Property, or any other right, title, or interest that otherwise would have been terminated, released, and discharged pursuant to this Agreement.

3. Further Assurances. Longson hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

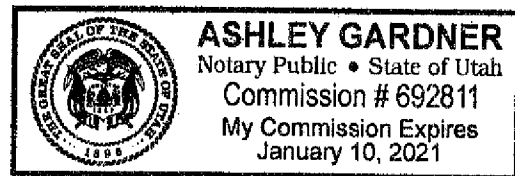
