#### ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

This Assignment of Security Interest in Trademarks ("<u>Assignment</u>"), effective as of January 30, 2020, is made by Citibank, N.A., as Administrative Agent and Collateral Agent (in such capacities, the "<u>Existing Agent</u>") under the Credit Agreement, as defined below and Cortland Capital Market Services LLC as successor Administrative Agent and Collateral Agent (in such capacities, the "<u>Successor Agent</u>") under the Credit Agreement, in connection with:

- (i) that certain Credit Agreement dated as of December 5, 2016 (as amended pursuant to the Technical Amendment to Credit Agreement dated as of September 30, 2019, Amendment No. 2 to Credit Agreement dated as of December 31, 2019, the Transfer Agreement (as defined below) and as the same may be amended, amended and restated, supplemented or otherwise modified from time to time in accordance with the terms thereof prior to the date hereof, the "Credit Agreement"), among Moran Foods, LLC ("Moran"), the lenders from time to time party thereto, the Existing Agent and the other parties party thereto;
- (ii) the Term Loan Pledge and Security Agreement, by and among Moran and the other grantors thereto and the Existing Agent, dated as of December 5, 2016 (the "Collateral Agreement");
- (iii) the Trademark Security Agreement, entered into by Moran and the Existing Agent, dated as of December 5, 2016 (the "<u>First Trademark Security Agreement</u>") and recorded with the United States Patent and Trademark Office (the "<u>USPTO</u>") on December 5, 2016 at Reel/Frame No. 5934/0836;
- (iv) the Trademark Security Agreement, entered into by Moran and the Existing Agent, dated as of September 16, 2019 (the "Second Trademark Security Agreement") and recorded with the USPTO on September 18, 2019 at Reel/Frame No. 6749/0220;
- (v) the Trademark Security Agreement, entered into by Moran and the Existing Agent, dated as of October 16, 2019 (the "<u>Third Trademark Security Agreement</u>" and, together with the First Trademark Security Agreement and the Second Trademark Security Agreement, the "<u>Trademark Security Agreements</u>") and recorded with the USPTO on October 17, 2019 at Reel/Frame No. 6773/0357; and
- (vi) the Agency Transition Agreement and Amendment No. 3 to Term Loan Credit Agreement, entered into by and among the Existing Agent, Successor Agent, the loan parties party thereto and the lenders under the Credit Agreement party thereto (the "<u>Transfer Agreement</u>"), dated as of January 30, 2020.

Unless expressly provided otherwise herein, terms defined or that have their meaning provided for in the Collateral Agreement, the Trademark Security Agreements or the Transfer Agreement, as applicable, shall have the same meaning when used in this Assignment (including those defined terms incorporated by reference therein).

#### WITNESSETH

WHEREAS, pursuant to the Collateral Agreement and Trademark Security Agreements, Moran granted to the Existing Agent, for the benefit of the Secured Parties thereto, a security interest

in all of the Collateral, including the Trademark Collateral listed in <u>Schedule A</u> hereto (the "<u>Secured IP</u>"); and

WHEREAS, pursuant to the Transfer Agreement, Moran has agreed to grant to the Successor Agent a security interest in the Secured IP;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

SECTION 1. <u>Assignment of Security Interest</u>. The Existing Agent hereby assigns to the Successor Agent each of the liens and security interests assigned, pledged, mortgaged or otherwise created in favor of the Existing Agent under the Collateral Agreement and Trademark Security Agreements over the Secured IP, and the Successor Agent hereby assumes all such liens and security interests for the benefit of the Secured Parties.

SECTION 2. <u>Purpose</u>. This Assignment has been executed and delivered by the Existing Agent and Successor Agent for the purpose of recording the assignment of the liens and security interests set forth herein with the USPTO. The liens and security interests referred to herein are expressly subject to the terms and conditions of the Trademark Security Agreements and the Transfer Agreement. The Trademark Security Agreements and the Transfer Agreement (and all rights and remedies of the Secured Parties thereunder) shall remain in full force and effect in accordance with their terms.

SECTION 3. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT GIVING EFFECT TO ANY CONFLICTS OF LAWS PROVISIONS THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.

SECTION 4. <u>Counterparts</u>. This Assignment may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. This Assignment shall become effective when it shall have been executed by the Successor Agent and when the Successor Agent shall have received counterparts hereof which bear the signature of the Existing Agent, and thereafter shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. Delivery of an executed counterpart of a signature page of this Assignment by telecopy or other electronic imaging means (including in .pdf format) shall be effective as delivery of a manually executed counterpart of this Assignment.
