**TRADEMARK SECURITY  
AGREEMENT SUPPLEMENT NO. 1**

**Grant of Security Interest  
in United States TRADEMARKS**

This TRADEMARK SECURITY AGREEMENT SUPPLEMENT NO. 1, dated as of January 30, 2020 (this "Agreement") is made by CLARK EQUIPMENT COMPANY, a Delaware corporation with an address at 250 East Beaton Drive, West Fargo, ND 58078, (the "Grantor"), in favor of BANK OF AMERICA, N.A., a national banking association with an address at One Bryant Park, New York, NY 10036, as the Administrative Agent (the "Grantee").

WITNESSETH:

WHEREAS, the Grantor and the Grantee are party to that certain Security Agreement, dated as of May 18, 2017 (as amended, supplemented, restated or otherwise modified from time to time, the "Security Agreement") entered into pursuant to that certain ABL Credit Agreement, dated as of May 18, 2017 (as amended, supplemented, restated or otherwise modified from time to time) by and among Doosan Bobcat Inc., Clark Equipment Company, certain other parties and the Grantee;

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Grantee, a continuing security interest in all of the Trademark Collateral (as defined below) now owned by the Grantor or in which the Grantor now has any right, title or interest, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations;

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Grantor hereby grants to Grantee for the benefit of the Secured Parties, a security interest in all of the Trademarks now owned by Grantor and listed on Schedule A hereto (the "Trademark Collateral").

THE GRANTOR authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Agreement.

THE GRANTOR does hereby further acknowledge and affirm that the rights and remedies of the Lenders with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Credit Agreement and the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of a conflict between this Agreement and the Security Agreement, the Security Agreement shall control.

All defined terms not otherwise defined in this Agreement shall have the meanings sets forth in the Security Agreement.

This Agreement and the security interest granted hereby shall terminate in accordance with the terms of the Security Agreement.

This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

This Agreement and the rights and obligations of the parties under this agreement shall be

governed by, and construed and interpreted in accordance with, the law of the state of New York.
