**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of February 14, 2020 by ARENA LIMITED SPV, LLC, as administrative agent ("Agent"), in favor of STRATERA HOLDINGS, LLC, formerly known as Behringer Harvard Holdings, LLC, a Delaware limited liability company ("Company"). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

WHEREAS, the Company entered into a certain trademark security agreement dated June 5, 2017 (the "Trademark Security Agreement") with Agent, notice of which was recorded on June 5, 2017 at the United States Patent and Trademark Office at Reel 6077, Frame 0059.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby unconditionally and expressly releases, terminates, and extinguishes any and all of its right, title and interest in and to any and all liens and security interests it may have upon the Trademark Collateral and the trademarks listed on Schedule I.

Agent consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon such trademarks.
