WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, including all of the goodwill of the business connected with the use of and symbolized by the Trademark Collateral, and assigns, transfers and conveys to Grantors the Security Interest in such Trademark Collateral.
