RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is entered into as of March 6, 2020 by JPMorgan Chase Bank, N.A., a National Banking Association located at 1300 East Ninth St., Floor 13, Cleveland, Ohio, 44114, in its capacity as administrative collateral agent for the Lenders party to the Credit Agreement referred to below (the “Assignor”), in favor of Cott Holdings Inc., a Delaware corporation with offices located at 4221 West Boy Scout Boulevard, Corporate Center III, Suite 400, Tampa, Florida 33607 (“Cott Holdings”), DS Services of America, Inc., a Delaware corporation with offices located at 2300 Windy Ridge Parkway, Suite 500N, Atlanta, Georgia 30339 (“DS Services”), Mountain Valley Spring Company, LLC, an Arkansas limited liability company with offices located at 150 Central Avenue, Hot Springs, Arkansas, 71901 (“Mountain Valley”), EntrePure Industries, Inc., also known as Entre Pure Industries, Inc. DBA Avant Premium Water & Ice, a Colorado corporation with offices located at 1200 N. Rabb Road, Suite A, LaFeria Texas, United States 78559 (“EntrePure”) and Primo Water Operations, Inc., a Delaware corporation with offices located at 101 North Cherry Street, Suite 501, Winston-Salem, North Carolina, United States 27101 (“Primo Operations,” and, together with Cott Holdings, DS Services, Mountain Valley and EntrePure, collectively, the “Assignees”). Capitalized terms used but not defined herein shall have the meanings given to them in the Credit Agreement, Security Agreement, 2016 Reaffirmation Agreement, 2018 Reaffirmation Agreement, Mountain Valley Joinder Agreement, Primo Parties Joinder Agreement, or applicable Trademark Security Agreement, as applicable (each as defined herein).

WHEREAS, reference is made to that certain:

- a) Amended and Restated Credit Agreement, dated as of August 3, 2016, by and among Cott Corporation Corporation Cott, a corporation organized under the laws of Canada (“Cott Corporation”), Cott Beverages Inc., a Georgia corporation (“Cott Beverages”), Cliffstar LLC, a Delaware limited liability company (“Cliffstar”), Cott Beverages Limited, a company organized under the laws of England and Wales, and DS Services, and certain other subsidiaries of Cott Corporation party thereto, as Borrowers and/or Guarantors, the Lenders party thereto, JPMorgan Chase Bank, N.A., London Branch, as UK Security Trustee, JPMorgan Chase Bank, N.A., as Administrative Agent and Administrative Collateral Agent, and each of the other parties party thereto (as amended, restated, supplemented or modified from time to time, the “Prior Credit Agreement”);
- b) Second Amended and Restated Credit Agreement, dated as of January 30, 2018, by and among Cott Corporation, Aquaterra Corporation, a corporation organized under the laws of Canada, Cott Holdings, DS Services, S.&D. Coffee, Inc., also known as S&D Coffee, Inc. and S & D Coffee, Inc., a North Carolina corporation with offices located at 300 Concord Parkway South, Concord, NC 28027 (“S&D”), Aimia Foods Limited, a company organized under the laws of England and Wales, and certain subsidiaries of Cott Corporation party thereto, as Borrowers and/or Guarantors, the Lenders party thereto, JPMorgan Chase Bank, N.A., London Branch, as UK Security Trustee, JPMorgan Chase Bank, N.A., as Administrative Agent and Administrative Collateral Agent and each of the other parties party thereto (the “Restated Credit Agreement”; the Prior Credit Agreement, as amended and restated by the Restated Credit Agreement and as it may be further

amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

- c) U.S. Pledge and Security Agreement, dated as of August 17, 2010, by and among the Assignor, Cott Corporation, and the other grantors named therein (as it may be amended, restated, supplemented or modified from time to time, the “Security Agreement”);
- d) Reaffirmation Agreement; Grant and Amendment No. 3 to U.S. Security Agreement, dated as of August 3, 2016, by and among the Assignor, Cott Corporation, and the other parties thereto (as it may be amended, restated, supplemented or modified from time to time, the “2016 Reaffirmation Agreement”);
- e) Reaffirmation and Security Agreement, dated as of January 30, 2018, by and among the Assignor, S&D, DS Services, and the other parties party thereto (as it may be amended, restated, supplemented or modified from time to time, the “2018 Reaffirmation Agreement”);
- f) Joinder Agreement, dated as of November 13, 2018, by and between the Assignor and Mountain Valley (as it may be amended, restated, supplemented or modified from time to time, the “Mountain Valley Joinder Agreement”);
- g) Joinder Agreement, dated as of March 2, 2020, by and among the Assignor, Primo Operations, and the other parties party thereto (as it may be amended, restated, supplemented or modified from time to time, the “Primo Parties Joinder Agreement”);
- h) U.S. Trademark Security Agreement, dated as of August 17, 2010, by and among the Assignor, Cliffstar and Cott Beverages (“2010 Trademark Security Agreement”);
- i) U.S. Trademark Security Agreement (Supplemental), dated as of May 9, 2012, by and among the Assignor, Cliffstar and Cott Beverages (“2012 Supplemental Trademark Security Agreement”);
- j) U.S. Trademark Security Agreement (Reaffirmation Grant), dated as of August 31, 2016, by and among the Assignor, Cliffstar and Cott Beverages (“2016 Reaffirmation Trademark Security Agreement”);
- k) U.S. Trademark Security Agreement (Supplemental), dated as of August 31, 2016, by and among the Assignor, Cliffstar, Cott Beverages and DS Services (“2016 Supplemental Trademark Security Agreement”);
- l) U.S. Trademark Security Agreement (Supplemental), dated as of June 15, 2017, by and between the Assignor and DS Services (“2017 Supplemental Trademark Security Agreement”);

- m) U.S. Trademark Security Agreement (Supplemental), dated as of January 30, 2018, by and among the Assignor, S&D and DS Services (“2018 Supplemental Trademark Security Agreement”);
- n) U.S. Trademark Security Agreement (Reaffirmation Grant), dated as of January 30, 2018, by and among the Assignor, Cott Holdings, DS Services and S&D (“2018 Reaffirmation Trademark Security Agreement”);
- o) Trademark Security Agreement (Joinder), dated as of November 13, 2018, by and between the Assignor and Mountain Valley (“Mountain Valley Joinder Trademark Security Agreement”); and
- p) Trademark Security Agreement (Joinder), dated as of March 2, 2020, by and among the Assignor, Primo Operations and EntrePure (“Primo Joinder Trademark Security Agreement,” and, together with the 2010 Trademark Security Agreement, the 2012 Supplemental Trademark Security Agreement, the 2016 Reaffirmation Trademark Security Agreement, the 2016 Supplemental Trademark Security Agreement, the 2017 Supplemental Trademark Security Agreement, the 2018 Supplemental Trademark Security Agreement, the 2018 Reaffirmation Trademark Security Agreement and the Mountain Valley Joinder Trademark Security Agreement, the “Trademark Security Agreements”);

WHEREAS, pursuant to the terms and conditions of the Security Agreement, the 2018 Reaffirmation Agreement, the Mountain Valley Joinder Agreement, the Primo Parties Joinder Agreement, and the Trademark Security Agreements, in furtherance of the reaffirmations set forth in the 2018 Reaffirmation Agreement and Section 2 of the 2016 Reaffirmation Trademark Security Agreement, 2018 Reaffirmation Trademark Security Agreement, the 2016 Supplemental Trademark Security Agreement and the 2018 Supplemental Trademark Security Agreement, each Assignee pledged, assigned and granted to the Assignor, on behalf of and for the ratable benefit of the Secured Parties, a security interest in all of such Assignee’s right, title and interest in, to and under the following personal property and other assets, in each case, whether then owned by or owing to, or thereafter acquired by or arising in favor of such Assignee (including under any trade name or derivations thereof), and whether owned or consigned by or to, or leased from or to, such Assignee, and regardless of where located (collectively, the “Trademark Collateral”), to secure the prompt and complete payment and performance of the Secured Obligations:

- a) all trademarks (including service marks), trade names, trade dress and trade styles, internet domain names and other source identifiers, and the registrations and applications for registration thereof including but not limited to the registered trademarks and service marks and the trademarks and service marks applications set forth on Schedule A (with respect to Cott Holdings, DS Services and Mountain Valley) and Schedule B (with respect to Primo Operations and EntrePure) hereto and the goodwill of the business symbolized by the foregoing;
- b) all licenses of the foregoing, whether as licensee or licensor;
- c) all renewals of the foregoing;

- d) all income, royalties, damages and payments then or thereafter due or payable with respect thereto, including, without limitation, damages, claims and payments for past and future infringements thereof;
- e) the right to sue for past, present and future infringements of the foregoing;
- f) all rights corresponding to any of the foregoing throughout the world; and
- g) all accessions to, substitutions for and replacements, proceeds (including Stock Rights), insurance proceeds and products of the foregoing, together with all books and records, customer lists, credit files, computer files, programs, printouts and other computer materials and records related thereto and any General Intangibles at any time evidencing or relating to any of the foregoing.

WHEREAS, (i) the 2010 Trademark Security Agreement was recorded with the United States Patent & Trademark Office (“USPTO”) on August 31, 2010 at Reel/Frame No. 4270/0206; (ii) the 2012 Supplemental Trademark Security Agreement was recorded with the USPTO on May 11, 2012 at Reel/Frame No. 4778/0024; (iii) the 2016 Reaffirmation Trademark Security Agreement was recorded with the USPTO on September 1, 2016 at Reel/Frame No. 5869/0075; (iv) the 2016 Supplemental Trademark Security Agreement was filed with the USPTO on September 1, 2016 at Reel/Frame No. 5868/0589; (v) the 2017 Supplemental Trademark Security Agreement was recorded with the USPTO on June 16, 2017 at Reel/Frame No. 6085/0858; (vi) the 2018 Supplemental Trademark Security Agreement was recorded with the USPTO on January 30, 2018 at Reel/Frame No. 6260/0978; (vii) the 2018 Reaffirmation Trademark Security Agreement was recorded with the USPTO on January 31, 2018 at Reel/Frame No. 6262/0683; (viii) the Mountain Valley Joinder Trademark Security Agreement was recorded with the USPTO on November 14, 2018 at Reel/Frame No. 6537/0473; and (ix) for the avoidance of doubt, the Primo Joinder Trademark Security Agreement was not recorded with the USPTO;

WHEREAS, the Assignees have paid and performed in full the Secured Obligations, and as a result, the Assignor has agreed to terminate and release its security interest with respect to the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse, its security interest in all of each Assignee’s right, title and interest in, to and under the Trademark Collateral, including the trademarks listed on Schedule A and Schedule B hereto.

The Assignor hereby authorizes the Assignees or the Assignees’ designee to record this Release with the USPTO. For clarity, the parties acknowledge and agree that this Release shall be recorded with the USPTO with respect to the Trademark Collateral set forth on Schedule A (i.e., the Trademark Collateral of Cott Holdings, DS Services, and Mountain Valley) but shall not be recorded with the USPTO with respect to Schedule B (i.e., the Trademark Collateral of Primo

Operations and EntrePure), though for the avoidance of doubt the effectiveness of this Release extends to all trademarks on Schedule A and on Schedule B.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, AND ANY DISPUTE BETWEEN THE ASSIGNEES AND THE ASSIGNOR ARISING OUT OF, CONNECTED WITH, RELATED TO, OR INCIDENTAL TO THE RELATIONSHIP ESTABLISHED BETWEEN THEM IN CONNECTION WITH, THIS RELEASE, AND WHETHER ARISING IN CONTRACT, TORT, EQUITY, OR OTHERWISE, SHALL BE RESOLVED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK (INCLUDING 5-1401 OF THE GENERAL OBLIGATION LAW OF THE STATE OF NEW YORK BUT OTHERWISE WITHOUT REGARD TO THE CONFLICTS OF LAWS PROVISIONS).
