**TERMINATION AND RELEASE OF PATENTS, TRADEMARKS AND COPYRIGHTS  
SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF PATENTS, TRADEMARKS AND COPYRIGHTS SECURITY AGREEMENT** (this "Termination"), is dated as of March 2, 2020, and made by **NEWSPRING MEZZANINE CAPITAL III, L.P.**, as collateral agent (the "Grantee"), to **ALTUS RECEIVABLES MANAGEMENT, INC. (f/k/a ALTUS GTS INC.)**, a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Patents, Trademarks and Copyrights Security Agreement dated as of April 1, 2016, made by Grantor in favor of Grantee (the "IP Security Agreement"), a security interest was granted by the Grantor to Grantee for its benefit and the benefit of Lenders (as defined in the IP Security Agreement), in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the IP Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on April 13, 2016 at Reel/Frame 5770/0494, and with the United States Copyright Office on April 14, 2016 at Volume 9934, Doc. No. 959;

WHEREAS, Grantee now desires to terminate the IP Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature in (a) each Trademark and Copyright (as defined in the IP Security Agreement), including, but not limited to, those listed on Exhibit A attached hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark and Copyright and (b) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Copyright, or (ii) injury to the goodwill associated with any Trademark or Copyright.

2. Release of Security Interest. Grantee, on behalf of itself and the Lenders, hereby terminates the IP Security Agreement and terminates, releases and discharges its security interest in Grantor's entire right, title, and interest in and to the Intellectual Property. Grantee authorizes the recordation of this Termination with the USPTO and the USCO at the Grantor's expense.

3. Further Assurances. Grantee agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Termination.
