TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), is dated as of March 23, 2020, and made by Solar Capital Ltd., a Maryland corporation, as collateral agent, having an office at 500 Park Avenue, 3rd Floor, New York, NY 10022 (the "Agent") to Senseonics, Incorporated, a Delaware corporation, and Senseonics Holdings, Inc., a Delaware corporation (individually and collectively, the "Grantor"). Unless otherwise defined herein, capitalized terms used herein shall have the same meanings ascribed to them in the Loan and Security Agreement (as defined below).

WHEREAS, the Grantor, Agent, and the other parties thereto have entered into (i) that certain Loan and Security Agreement, dated as of July 16, 2019 (as amended, restated, or otherwise modified from time to time, the "Loan and Security Agreement") and (ii) that certain Reaffirmation Agreement with the Lenders and Agent, dated as of July 25, 2019 (as amended, restated, or otherwise modified from time to time, the "Reaffirmation Agreement");

WHEREAS, pursuant to the Loan and Security Agreement and the Reaffirmation Agreement, the Grantor executed and delivered to Agent that certain Intellectual Property Security Agreement, dated as of July 25, 2019 and recorded in the Assignment Recordation Branch of the United States Patent and Trademark Office on August 1, 2019, at Reel 6709 and Frame 0206 (the "Intellectual Property Security Agreement"), pursuant to which the Grantor granted to Agent for the benefit of the Lenders a continuing security interest in the Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement); and


WHEREAS, Agent now desires to terminate and release the security interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby terminates, releases and discharges its security interest in the Intellectual Property Collateral, including the trademark registrations and applications referred to on Schedule A hereto, and hereby reassigns to the Grantor, as applicable, any right, title, or interest it may have in the Intellectual Property Collateral of the Grantor, without recourse or representation or warranty, express or implied, of any kind.






