WHEREAS, pursuant to (a) that certain Security Agreement, dated as of July 31, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") between the Grantors (as defined therein) thereto and the Original Agent pursuant to which the Grantors granted a security interest to the Original Agent in all right, title or interest in or to any and all of the Intellectual Property (as defined therein) then owned or at any time thereafter acquired by such Grantor, (b) that certain Trademark Security Agreement by and among the Grantors (as defined therein) and the Original Agent dated as of July 31, 2017 and recorded with the United States Patent and Trademark Office (the "USPTO") at Reel 6118, Frame 0001 on July 31, 2017 (as partially released under that certain Release of Security Interest in Specified Trademark Collateral dated August 5, 2019 and recorded with the USPTO at Reel 6713, Frame 0006 (the "Partial Release")), the Grantors pledged and granted to the Original Agent for the ratable benefit of the Secured Parties a security interest in all right, title or interest in and to the Trademark Collateral (as defined therein), and (c) that certain Patent Security Agreement by and among the Grantors (as defined therein) and the Original Agent dated as of July 31, 2017 and recorded with the USPTO at Reel 043142, Frame 0744 on July 31, 2017, the Grantors pledged and granted to the Original Agent for the ratable benefit of the Secured Parties a security interest in all right, title or interest in and to the Patent Collateral (as defined therein) (the Patent Collateral, together with the Trademark Collateral but excluding the Specified Trademark Collateral (as defined in the Partial Release) released under the Partial Release, the "IP Collateral") (the agreements described in (b) and (c) together, the "IP Security Agreements").
