**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of April 1, 2020 (the “Effective Date”), is made by DEUTSCHE BANK AG NEW YORK BRANCH, in its capacity as Administrative Agent and Collateral Agent (the “Agent”), in favor of the grantor party identified on the signature page hereto (the “Grantor”).

WHEREAS, pursuant to that certain Agency Resignation, Appointment, Assignment and Assumption Agreement, dated as of August 26, 2016 (the “Successor Agent Agreement”), (a) DEUTSCHE BANK TRUST COMPANY AMERICAS, as Prior Agent resigned as Collateral Agent, (b) DEUTSCHE BANK AG NEW YORK BRANCH, as Successor Agent was appointed Collateral Agent and (c) the Successor Agent accepted its appointment as Collateral Agent;

WHEREAS, reference is made to that certain Amended and Restated Term Loan Credit Agreement, dated as of December 9, 2010 (as amended by Amendment No. 1, dated as of March 7, 2013, as further amended by Amendment No. 2, dated as of March 28, 2014, as further amended by Amendment No. 3, dated as of August 26, 2016, as further amended by Amendment No. 4, dated as of March 2, 2018, and as further amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among OMNOVA Solutions Inc., as borrower, the Agent, the lenders from time to time party thereto and the other parties thereto;

WHEREAS, pursuant to that certain Amended and Restated Security Agreement, dated as of August 26, 2016, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Successor Agent Agreement, the Grantor executed and delivered a Notice of Succession of Agency, dated as of August 26, 2016 (the “Notice 1”), for recordal with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Successor Agent Agreement, the Grantor executed and delivered a Notice of Succession of Agency, dated as of August 26, 2016 (the “Notice 2” and, together with Notice 1, the “Notices”), for recordal with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Grant of Security Interest In Certain Patents and Trademarks, dated as of August 26, 2016 (the “August 2016 Grant”), for recordal with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Grant of Security Interest In Certain Patents and Trademarks, dated as of March 2, 2018 (the “March 2018 Grant” and, together with the August 2016 Grant, the “Grants”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Notice 1 was recorded with the United States Patent and Trademark Office on August 29, 2016 at Reel/Frame 5864/0909;

WHEREAS, the Notice 2 was recorded with the United States Patent and Trademark Office on August 29, 2016 at Reel/Frame 5866/0931;

WHEREAS, the August 2016 Grant was recorded with the United States Patent and Trademark Office on August 30, 2016 at Reel/Frame 5868/0336;

WHEREAS, the March 2018 Grant was recorded with the United States Patent and Trademark Office on March 2, 2018 at Reel/Frame 6283/0108;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Successor Agent Agreement, the Security Agreement, the Notices or the Grants, as applicable.

2. Release. Pursuant to Section 10.11 of the Credit Agreement and Section 10.08 of the Security Agreement, the Agent, without representation or warranty of any kind, hereby releases, relinquishes, discharges, terminates and cancels all of its security interest in and to the Intellectual Property Collateral, including the trademark registrations and applications set forth Schedule I attached hereto, arising under the Successor Agent Agreement, the Security Agreement, the Notices and the Grants. If and to the extent that the Agent has acquired any right, title or interest in and to the Intellectual Property Collateral under the Notices and the Grants, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor. The Agent hereby authorizes the Grantor and its successors, assigns or other legal representatives to make filings with the United States Patent and Trademark Office and other necessary filings, in each case at the sole expense of the Grantor, to evidence and effectuate the release and termination of the Agent's security interests in the Intellectual Property Collateral.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Notices and the Grants.



The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
