## **RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS**

**THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS** (this “Release”) is made as of the day of March 31, 2020 by **KeyBank National Association**, as **collateral agent** (in such capacity, the “Agent”) for the benefit of **OverDrive, Inc.**, a Delaware corporation (“OverDrive”), including as successor to the assets of **Teachers Notebook, LLC**, a dissolved New Jersey limited liability company (“Teachers”).

**WHEREAS**, pursuant to (a) that certain Intellectual Property Security Agreement, dated as of December 14, 2012, between OverDrive and the Agent (as heretofore amended and supplemented, the “OverDrive IP Security Agreement”), (b) that certain Intellectual Property Security Agreement, dated as of March 28, 2014, between Teachers and the Agent (as heretofore amended and supplemented, the “Teachers IP Security Agreement”), and (c) that certain Confirmation and Supplement of Intellectual Property Security Agreements, dated as of May 14, 2014, between OverDrive, Teachers and the Agent (the “Supplemental IP Security Agreement” and, together with the OverDrive IP Security Agreement and the Teachers IP Security Agreement, the “IP Security Agreements”) OverDrive and Teachers pledged, assigned and granted to the Agent a continuing security interest in all of their right, title and interest in and to certain collateral including, without limitation, (i) the trademark registrations and applications set forth on Exhibit A of the OverDrive IP Security Agreement (and listed on Exhibit I attached hereto), along with the goodwill associated therewith, (ii) the trademark registrations and applications set forth on Exhibit A of the Teachers IP Security Agreement (and listed on Exhibit II attached hereto), along with the goodwill associated therewith, and (iii) the patent and trademark registrations and applications set forth on Exhibit A of the Supplemental IP Security Agreement (and listed on Exhibit III attached hereto), along with the goodwill associated therewith (collectively, the “Proprietary Collateral”); and

**WHEREAS**, the IP Security Agreements (or amendments and supplements thereto) were recorded with the Assignment Division of the U.S. Patent & Trademark Office:

- (i) on February 21, 2013 at Reel 4968 and Frame 0159,
- (ii) on April 1, 2014 at Reel 5249 and Frame 0159, and
- (iii) on May 15, 2014 at Reel 5280 and Frame 0495.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates each IP Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Proprietary Collateral, including, without limitation, the Proprietary Collateral listed on Exhibits I, II and III attached hereto.

If and to the extent that the Agent has acquired any right, title or interest to any of the Proprietary Collateral, whether from Teacher or OverDrive, it hereby assigns and transfers such rights, title or interest to OverDrive.

The Agent shall take all further actions, and provide to OverDrive and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by OverDrive to more fully and effectively effectuate the purposes of this Release, so

long as OverDrive reimburses the Agent for its costs and expenses in connection with any and all of the foregoing.

The Agent hereby acknowledges that this Release shall be filed with the United States Patent and Trademark Office.
