

# AGREEMENT AND PLAN OF MERGER

AGREEMENT AND PLAN OF MERGER ("Agreement"), dated as of December [19], 2019, by and among:

a.	CHEAP CHEAP MOVING BOXES.COM, LLC, a Texas limited liability company	("Cheap");
b.	RTIC COOLERS, LLC, a Texas limited liability company	("RTIC Coolers" or "Surviving Company");
c.	RTIC WEB SERVICES, LLC, a Texas limited liability company	("RTIC Web");
d.	RTIC DRINKWARE, LLC, a Texas limited liability company	("RTIC Drinkware");
e.	C2S TECHNOLOGY, LLC, a Texas limited liability company	("C2S");
f.	VELKY WEB SERVICES, LLC, a Texas limited liability company	("Velky Web");
g.	RTIC IP, LLC, a Texas limited liability company	("RTIC IP");
h.	RTIC SOFT SIDED COOLERS, LLC, a Texas limited liability company	("RTIC Soft");
i.	VELKY IP, LLC, a Texas limited liability company	("Velky IP");
j.	VELKY BED, LLC, a Texas limited liability company	("Velky Bed");
k.	RTIC GEAR, LLC, a Texas limited liability company	("RTIC Gear", and together with Cheap, RTIC Web, RTIC Drinkware, C2S, Velky Web, RTIC IP, RTIC Soft, Velky IP, Velky Bed, and RTIC Coolers, the "Companies")

WHEREAS, the Companies are all owned subsidiaries of Velky Brands, LLC, a Delaware limited liability company ("Velky Brands");

WHEREAS, the Manager of each of the Companies deems it advisable, and for the benefit and in the best interest of the Companies and their respective sole member, Velky Brands, to effect a nontaxable reorganization by merging Cheap, RTIC Web, RTIC Drinkware, C2S, Velky Web, RTIC IP, RTIC Soft, Velky IP, Velky Bed, and RTIC Gear with and into RTIC Coolers (the "Merger"), upon the terms and conditions set forth in this Agreement and pursuant to the requirements of the Texas Business Organizations Code (the "TBOC");

WHEREAS, in connection with the Merger, RTIC Coolers will change its name to RTIC Outdoors, LLC; and

WHEREAS, the Manager of each of the Companies has approved this Agreement and directed that this Agreement be submitted to its respective sole member, Velky Brands, for approval and adoption to the extent required by the TBOC.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained in this Agreement, and for the purpose of prescribing the terms and conditions of the Merger, and such other details and provisions as are deemed necessary or desirable, the parties agree as follows:

## 1. Merger.

- (a) In accordance with the TBOC, at the Effective Time (as defined below), Cheap, RTIC Web, RTIC Drinkware, C2S, Velky Web, RTIC IP, RTIC Soft, Velky IP, Velky Bed, and RTIC Gear shall be merged with and into RTIC Coolers, with RTIC Coolers being the Surviving Company and continuing to exist under and be governed by the TBOC.
- (b) On the filing with the Secretary of State for the State of Texas of a Certificate of Merger, RTIC Coolers will change its name to RTIC Outdoors, LLC.
- (c) Except as otherwise set forth in this Agreement, the corporate existence and identity of RTIC Coolers, as the Surviving Company, with all its purposes, powers, franchises, privileges, rights and immunities, shall continue unaffected and unimpaired by the Merger, and the corporate existence and identity of the Companies, with all of its purposes, powers, franchises, privileges, rights and immunities, at the Effective Time, shall be merged with and into and fully vest with RTIC Coolers, as the Surviving Company, and the separate corporate existence and identity of the Companies shall thereafter cease except to the extent continued by statute.
- (d) It is intended that the Merger as set forth in this Agreement occur in accordance with the applicable provisions of the TBOC, and accordingly (a) shall constitute a statutory merger within the meaning of Section 368(a)(1)(A) of the Internal Revenue Code of 1986 (as amended, the "Code") and (b) shall qualify for nonrecognition treatment in accordance with the provisions of Section 354 of the Code.

## 2. Effective Time; Effect of Merger.

- (a) The Merger shall become effective (the "Effective Time") upon compliance with all applicable requirements of the TBOC and the filing with the Secretary of State for the State of Texas of a Certificate of Merger.
- 3. <u>Organizational Documents</u>. The Certificate of Formation and the Company Agreement of RTIC Coolers, each as in effect at the Effective Time, shall be the Certificate of Formation and the Company Agreement of the Surviving Company until thereafter amended as provided therein or by the TBOC.
- 4. Officers and Managers. The managers and officers of the Surviving Company immediately prior to the Effective Time shall be the managers and officers of Surviving Company immediately following the Effective Time. All such managers and officers of the Surviving Company will serve in such capacities until their successors have been duly elected or appointed and qualified, or until their earlier death, resignation or removal in accordance with the Certificate of Formation and the Company Agreement of the Surviving Company.
- 5. <u>Merger Consideration</u>. At the Effective Time, all membership interests of the Companies issued and outstanding immediately prior to the Effective Time will, by virtue of the Merger and without any action on the part of the holder thereof, be cancelled and retired without payment of any consideration therefor. All membership interests of the Surviving Company issued and outstanding immediately prior to the Effective Time shall continue to be the issued and outstanding membership interests of the Surviving Company and no new membership interests of the Surviving Company shall be issued as a result of the Merger.
- 6. <u>Entire Agreement</u>. This Agreement together with the Certificate of Merger constitutes the sole and entire agreement of the parties to this Agreement with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, representations and warranties and agreements, both written and oral, with respect to such subject matter.
- 7. <u>Successors and Assigns</u>. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and permitted assigns.
- 8. <u>No Third-Party Beneficiaries</u>. This Agreement is for the sole benefit of the parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other person any legal or equitable right, benefit or remedy of any nature whatsoever, under or by reason of this Agreement.
- 9. <u>Headings</u>. The headings in this Agreement are for reference only and shall not affect the interpretation of this Agreement.
- 10. <u>Amendment and Modification</u>. This Agreement may only be amended, modified or supplemented by an agreement in writing signed by each party hereto.

- 11. <u>Severability</u>. If any term or provision of this Agreement is invalid, illegal or unenforceable in any jurisdiction, such invalidity, illegality or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. Upon such determination that any term or other provision is invalid, illegal or unenforceable, the parties hereto shall negotiate in good faith to modify this Agreement so as to effect the original intent of the parties as closely as possible in a mutually acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the greatest extent possible.
- 12. <u>Governing Law; Submission to Jurisdiction</u>. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Texas without giving effect to any choice or conflict of law provision or rule (whether of the State of Texas or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than those of the State of Texas.
- 13. <u>Counterparts</u>. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.
