# TERMINATION AND RELEASE OF FIRST PRIORITY AND JUNIOR PRIORITY SECURITY INTEREST IN TRADEMARK RIGHTS

TERMINATION AND RELEASE dated as of April 1, 2020, from DEUTSCHE BANK TRUST COMPANY AMERICAS, as Collateral Trustee (the "Collateral Trustee") to SPRINT COMMUNICATIONS COMPANY L.P., a Delaware limited partnership (the "Grantor").

### WITNESSETH:

WHEREAS, pursuant to the Security Agreement, dated as of February 3, 2017, in favor of the Collateral Trustee (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Security Agreement"), Grantor granted a security interest (the "Security Interest") to the Collateral Trustee in certain collateral, including Trademarks;

WHEREAS, pursuant to that certain Grant of First Priority and Junior Priority Security Interest in Trademark Rights dated as of February 3, 2017, among the Collateral Trustee and Grantor (the "<u>Trademark Security Agreement</u>"), Grantor, by reference to the Security Agreement, reaffirmed its intent to grant the Security Interest to the Collateral Trustee specifically in certain Collateral (as that term is defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 6, 2017 at Reel 6002 and Frame 0019.

WHEREAS, the Collateral Trustee now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Trustee hereby states as follows:

- 1. <u>Definitions</u>. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement.
- 2. <u>Release of Security Interest</u>. The Collateral Trustee hereby terminates, releases and discharges, without recourse, representation or warranty, its Security Interest in the Collateral, and any right, title or interest of the Collateral Trustee in such Collateral shall hereby cease and become void.
- 3. <u>Further Assurances</u>. The Collateral Trustee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably requested and prepared by the Grantor to effect the release of the Security Interest contemplated hereby, which shall be at Grantor's sole cost and expense.
