

# TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This Termination and Release of Trademark Security Agreement (<u>"IP Release"</u>) is made as of, April 1, 2020, by Ankura Trust Company, LLC (the "Collateral Agent") in favor of Moran Foods, LLC (the "Grantor").

### WITNESSETH

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of October 18, 2019, recorded in the United States Patent and Trademark Office, at Reel 6775, Frame 0338 on October 21, 2019 (the "<u>Trademark Security Agreement</u>") Grantor granted to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, under that certain Term Loan and Credit Agreement, dated as of September 30, 2019 by and among AIM Chassis LLC, the Grantor, the other Loan Parties party thereto, the Lenders party thereto and the Collateral Agent (as amended by Amendment No. 1 to Credit Agreement dated as of October 25, 2019, Amendment No. 2 to Credit Agreement dated as of January 31, 2020 and Amendment No. 4 to Credit Agreement dated as of February 7, 2020, and as the same further amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the "<u>Credit Agreement</u>"), a security interest in all of the Grantor's right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

WHEREAS, the Grantor has requested and Collateral Agent has agreed to provide this IP Release to confirm the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Collateral Agent hereby agrees as follows:

- 1. <u>Defined Terms</u>. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Credit Agreement, as applicable.
- 2. Release of Security Interest. Collateral Agent hereby terminates, releases, relinquishes and discharges its security interest in the Trademark Collateral, including without limitation, all of the Grantor's right, title and interest in and to each Trademark listed on Schedule 1 hereto, including the goodwill symbolized thereby, as well as any other lien or security interest it may have in the Trademark Collateral or any other collateral of the Grantor under the Trademark Security Agreement. The Collateral Agent further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantor and its successors and assigns in association with the Trademark Security Interest, and hereby releases the Grantor and its successors and assigns from all

covenants, obligations, liabilities and warranties in association with the Trademark Security Interest.

- 3. <u>Termination</u>. The Collateral Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.
- 4. <u>Authorization</u>. Collateral Agent hereby authorizes Grantor or Grantor's agent to record this IP Release with the United States Patent and Trademark Office.
- 5. <u>Choice of Law.</u> This IP Release and any claim, controversy or dispute arising under or related to this IP Release, whether in tort, contract (at law or in equity) or otherwise, shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
- 6. <u>Counterparts</u>. This Release may be executed in two or more counterparts, each of which shall constitute an original but all of which when taken together shall constitute but one contract. Delivery of an executed counterpart to this IP Release by facsimile or other electronic transmission shall be effective as delivery of a manually signed original.
