TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this “Trademark Assignment”) dated as of June 12, 2019 (the “Effective Date”), is made by and between Miami Instruments, LLC, a Florida limited liability company having a principal place of business at 8934 Irving Avenue, Surfside, FL 33154 (“Assignor”), and LivaNova USA, Inc., a Delaware corporation having a principal place of business at 100 Cyberonics Blvd. Houston, Texas 77058 (“Assignee”). Capitalized terms used herein but not defined shall have the respective meanings ascribed to such terms in the Purchase Agreement (as defined below).

WHEREAS, Assignor and Assignee have entered into an Asset Purchase Agreement dated as of June 12, 2019 (the “Purchase Agreement”), pursuant to which, among other things, Assignor has agreed to assign, transfer, sell and deliver to Assignee, and Assignee has agreed to acquire from Assignor, all of Assignor’s right, title and interest in and to the Transferred Trademarks (as defined below).

1. Transferred Trademarks. The term “Transferred Trademarks” means the trademarks and accompanying trademark registrations and trademark applications set forth on Schedule A attached hereto.

2. Assignment. For good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Assignor hereby irrevocably assigns, transfers, sells and delivers to Assignee all of Assignor’s right, title and interest in and to (i) the Transferred Trademarks, together with the goodwill of the business associated with the use of and symbolized by the Transferred Trademarks, (ii) all registrations and applications (including intent-to-use applications) for the Transferred Trademarks in all countries throughout the world and (iii) all rights corresponding to any of the foregoing by international treaties and conventions and otherwise throughout the world, including the right to claim priority from any of the Transferred Trademarks, any income, royalties, damages and payments now or hereafter due or payable in respect of any of the foregoing (other than any payment earned or due under any Seller Contract to the extent arising before the Closing) and any and all rights to past, present and future causes of action, lawsuits, judgments, claims and demands of any nature relating to the Transferred Trademarks, the same to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor, if this assignment and sale had not been made.

3. Assistance. Assignor shall execute and deliver or cause to be executed and delivered to Assignee such documents, affidavits, transfers, and conveyances as may be reasonably requested by Assignee to register, evidence or perfect Assignee’s title to any of the Transferred Trademarks. If Assignee is unable, after reasonable effort, to secure Assignor’s signature on a document reasonably necessary to register, evidence or perfect Assignee’s title to any of the Transferred Trademarks, Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents as Assignor’s agents and attorneys-in-fact, to act for and in Assignor’s behalf and stead to execute and file any such documents and to do all other lawfully permitted acts to further the purposes of this Trademark Assignment with the same legal force and effect as if executed by Assignor.

4. Recordation. Assignee shall be responsible for the preparation and filing of any documents to record or perfect Assignee's right, title and interest in, to and under the Transferred Trademarks (including with any applicable Governmental Authority). Assignor agrees that Assignee shall have the right to file or record this Trademark Assignment with the United States Patent and Trademark Office ("USPTO") or other such entities throughout the world, and Assignor authorizes and requests the relevant authorities to record Assignee as the assignee and owner of the Transferred Trademarks.

5. General Provisions.

(a) Nothing in this Trademark Assignment shall alter any liability or obligation of the Assignor or the Assignee arising under the Purchase Agreement, which shall govern the representations, warranties and obligations of the parties with respect to the Transferred Trademarks.

(b) This Trademark Assignment shall be binding upon, inure to the benefit of, and be enforceable by, the parties and their respective successors and assigns.

(c) This Trademark Assignment and all disputes or controversies arising out of or relating to this Trademark Assignment or the transactions contemplated hereby shall be governed by, and construed in accordance with, the internal laws of the State of Delaware, without regard to the laws of any other jurisdiction that might be applied because of the conflicts of laws principles of the State of Delaware.

(d) This Trademark Assignment may be executed in two or more counterparts, all of which shall be considered one and the same instrument and shall become effective when one or more counterparts have been signed by each of the parties and delivered to the other party.


