THIRD SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Third Supplement to Intellectual Property Security Agreement (this "Supplement") is made as of the 24th day of April, 2020 by OUTBRAIN INC., a Delaware corporation (the "Grantor") in favor of Silicon Valley Bank (the "Grantee").

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated November 20, 2014 and recorded with the Patent Division of the U.S. Patent and Trademark Office on November 21, 2014 at Reel 034315 and Frame 0093 and recorded with the Trademark Division of the U.S. Patent and Trademark Office on November 21, 2014 at Reel 5405 and Frame 0676 (as amended from time to time hereinafter, the "Existing Grant") in favor of the Grantee, pursuant to which the Grantor's pledged, assigned and granted a security interest in certain Intellectual Property Collateral (as defined therein);

WHEREAS, the Grantor executed and delivered a First Supplement to Intellectual Property Security Agreement dated January 27, 2016 and recorded with the Patent Division of the U.S. Patent and Trademark Office on February 1, 2016 at Reel 037662 and Frame 0655 (the "First Supplemental Grant") in favor of the Grantee; and

WHEREAS, the Grantor executed and delivered a Second Supplement to Intellectual Property Security Agreement dated August 9, 2016 and recorded with the Patent Division of the U.S. Patent and Trademark Office on August 10, 2016 at Reel 039645 and Frame 0110 and recorded with the Trademark Division of the U.S. Patent and Trademark Office on August 10, 2016 at Reel 5852 and Frame 0631 ("Second Supplemental Grant", and together with the Existing Grant and the First Supplemental Grant, collectively the "Grant") in favor of the Grantee; and

WHEREAS, the Grantor has developed additional Intellectual Property Collateral and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Intellectual Property Collateral in favor of the Grantee.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

- 1. <u>Definitions</u>. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
- 2. <u>Supplement to Exhibit B</u>. <u>Exhibit B</u> to the Grant is hereby supplemented, but not replaced, by <u>Schedule B-1</u> annexed hereto.
- 3. <u>Supplement to Exhibit C. Exhibit C</u> to the Grant is hereby supplemented, but not replaced, by <u>Schedule C-1</u> annexed hereto.

4. <u>Miscellaneous</u>:

a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.

b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
