TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT dated as of April 27, 2020 (as amended, supplemented or otherwise modified from time to time, this "Agreement") is made by CAROWINDS LLC, CEDAR FAIR, L.P., CEDAR POINT PARK LLC, DORNEY PARK LLC, KINGS DOMINION LLC, KINGS ISLAND PARK LLC, KNOTT'S BERRY FARM LLC, MICHIGAN'S ADVENTURE PARK LLC, MILLENNIUM OPERATIONS LLC, VALLEY FAIR LLC, MICHIGAN'S ADVENTURE PARK LLC AND WORLDS OF FUN LLC (each a "Grantor" and collectively, the "Grantors") in favor of THE BANK OF NEW YORK MELLON, as collateral agent (in such capacity, the "Notes Collateral Agent") for the Secured Parties (as defined in the Collateral Agreement referred to below).

WHEREAS, pursuant to that certain Collateral Agreement, entered into as of April 27, 2020 (as it may be amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), by and among Cedar Fair, L.P., Magnum Management Corporation, Millennium Operations LLC and Canada's Wonderland Company (together, the "Issuers"), the Grantors, the other Grantors (as defined in the Collateral Agreement) party thereto, and the Notes Collateral Agent, each Grantor assigned, transferred and granted to the Notes Collateral Agent, for the benefit of the Secured Parties, a security interest in all of its right, title and interest in, to and under all of the Collateral of such Grantor, to secure the prompt and complete payment and performance of such Grantor's Obligations; and

WHEREAS, under the terms of the Collateral Agreement, the Grantors have granted a security interest in certain property, including, without limitation, certain Intellectual Property of the Grantors to the Notes Collateral Agent for the benefit of the Secured Parties, and has agreed as a condition thereof to execute this Agreement for recording with the United States Patent and Trademark Office;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantors hereby agree as follows:

SECTION 1. <u>DEFINED TERMS</u>. Capitalized terms not otherwise defined herein have the meanings set forth in the Collateral Agreement.

SECTION 2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. As collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of such Grantors' Obligations, the Grantors hereby grant to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all of Grantors' right, title, and interest in, to and under the following, whether now owned or existing or at any time acquired by such Grantors or in which such Grantors now have or at any time in the future may acquire (collectively, the "Trademark Collateral"):

(a) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, trade dress, domain names, and other source or business identifiers, all registrations, recordings and renewals thereof, and all applications in connection therewith arising under the laws of the United States or Canada or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto, including, without limitation, each registered trademark and trademark application identified in Schedule A hereto, (ii) the right to obtain all renewals thereof, (iii) all of the goodwill associated with any of the foregoing, (iv) the right to sue or otherwise recover for any and all past, present and future infringements, dilutions or other violations thereof, (v) all income, royalties,

damages and other payments now and hereafter due and/or payable with respect thereto (including payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements, dilutions, or other violations thereof), and (vi) all other rights of any kind whatsoever accruing thereunder or pertaining thereto;

- (b) any written agreement providing for the grant by or to any Person of any right to use any Trademark and all income, royalties, and other payments due and/or payable with respect thereto; and
- (c) notwithstanding the foregoing, Trademark Collateral shall exclude trademark applications filed in the United States Patent and Trademark Office on the basis of the Grantors' "intent-to-use" such trademark, unless and until acceptable evidence of use of the Trademark has been filed and accepted with the United States Patent and Trademark Office pursuant to Section I(c) or Section I(d) of the Lanham Act (15 U.S.C. 1051, et seq.), to the extent that granting a Lien in such Trademark application prior to such filing would adversely affect the enforceability or validity of such Trademark application; provided that, upon filing such evidence, such application shall be automatically subject to the security interest granted herein and deemed to be included in the Trademark Collateral.

SECTION 3. <u>PRECEDENCE</u>. This Agreement has been executed in conjunction with the provisions of the Collateral Agreement. The rights and remedies of the Secured Parties with respect to the security interest granted herein are in addition to those set forth in Collateral Agreement, all terms and provisions of which are incorporated herein by reference. In the event of any conflict between the terms of this Agreement and the terms of the Collateral Agreement, the terms of the Collateral Agreement shall control.

SECTION 4. <u>RECORDATION</u>. The Grantors authorize and request that the United States Commissioner of Patents and Trademarks and any other applicable government officer record this Agreement.

SECTION 5. GENERAL.

- (a) <u>Governing Law</u>. THIS DOCUMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
- (b) <u>Counterparts</u>. This Agreement may be executed in any number of counterparts (including by facsimile), each of which when so executed, shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.
- (c) <u>Concerning the Notes Collateral Agent</u>. The recitals contained herein shall be taken as the statements of the Grantors and the Notes Collateral Agent assumes no responsibility for their correctness. The Notes Collateral Agent makes no representations as to the validity or sufficiency of this Agreement.
