NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of April 28, 2020 (this "Agreement"), is made by the undersigned Grantors (each, a "Grantor" and, collectively, the "Grantors") in favor of the Collateral Agent (as defined below) under the Indenture, dated as of April 28, 2020 (as amended, amended and restated, waived, supplemented or otherwise modified from time to time, the "Indenture"), among US Foods, Inc., a Delaware corporation (the "Parent Borrower"), the Subsidiary Guarantors from time to time party thereto and Wilmington Trust, National Association, as trustee and as collateral agent (in such capacity, together with its successors and assigns, the "Collateral Agent"), for the benefit of the Secured Parties.

WHEREAS, in connection with the Indenture, the Parent Borrower and certain of its Subsidiaries executed and delivered a Notes Collateral Agreement, dated as of April 28, 2020 (as amended, restated, supplemented, waived or otherwise modified from time to time, the "Collateral Agreement") in favor of the Collateral Agent;

WHEREAS, pursuant to the Collateral Agreement, each Grantor has granted to the Collateral Agent a security interest in its Intellectual Property, including any Intellectual Property acquired by such Grantor after the date thereof, including Trademarks; and

WHEREAS, the Grantors have duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantors and the Secured Parties hereby agree as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Indenture and the Collateral Agreement, as applicable.

SECTION 2. Confirmation of Security Interest. The Grantors hereby confirm that pursuant to the Collateral Agreement, subject to existing licenses to use the Trademarks granted by the Grantors in the ordinary course of their business, such Grantors have granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Trademarks of the Grantors (including, without limitation, those items listed on Schedule A hereto) and to the extent not otherwise included, all Proceeds and products of any and all of such Trademarks, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations of the Grantors in respect of the Notes issued under the Indenture, except that no security interest is or will be granted pursuant thereto in any right, title or interest of the Grantors under or in any Trademark Licenses with Persons other than the Parent Borrower, a Subsidiary of the Parent Borrower or an Affiliate thereof, for so long as, and to the extent that, the granting of such a security interest pursuant thereto would result in a breach, default or termination of such Trademark Licenses.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Grantors for the purpose of recording the security interest granted pursuant to the Collateral Agreement with the United States Patent and Trademark Office. This Agreement is expressly subject to the terms and conditions of the Collateral Agreement. The Collateral Agreement (and all rights and remedies of the Secured Parties thereunder) shall remain in full force and effect in accordance with its terms.


SECTION 4. Acknowledgment. The Grantors do hereby further acknowledge and affirm that the rights and remedies of the Secured Parties with respect to the security interest in the Trademarks are fully set forth in the Indenture and the Collateral Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. Any electronic signature hereof shall be of the same legal effect, validity or enforceability as a manually executed signature, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.






