Trademark Assignment

Seller has sold, assigned and transferred, and hereby does sell, assign and transfer unto Buyer the entire right, title and interest in and to the Trademarks, together with the goodwill associated therewith, that portion of the business to which the Trademarks pertain which business is ongoing and existing, renewals and extensions thereof, and the right to sue for, and recover for, any past infringements thereof, to be held and enjoyed by Buyer, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Seller had no sale and assignment of said Trademarks been made.
- 2. Seller agrees to execute such further documents reasonably required by Buyer to secure and enforce the rights granted to Buyer under this Trademark Assignment. The Parties consent that this Confirmatory Trademark Assignment may be recorded in any national trademark office.
