TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT is dated as of May 1, 2020 (this “**Assignment**”) and is by and between Dean Foods Company, a company organized under the laws of the State of Delaware and each of the Subsidiaries of Dean Foods Company listed on the signature pages hereto (each an “**Assignor**” and collectively the “**Assignors**”), on the one hand, and Dean Dairy IP, LLC, a limited liability company organized under the laws of the State of Delaware (“**Assignee**”) on the other hand. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Purchase Agreement (as defined below).

WHEREAS, Assignors are the owners of the trademarks and trademark registrations and applications identified on **Exhibit A** (collectively, the “**Assigned Trademarks**”);

WHEREAS, each of the Assignors and Dairy Farmers of America, Inc., a cooperative organized and existing under the laws of the State of Kansas and the indirect owner of all of the issued and outstanding equity interests of Assignee (“**DFA**”), have entered into that certain Asset Purchase Agreement, dated April 6, 2020 (the “**Purchase Agreement**”), pursuant to which the Assignors have agreed to sell, transfer, assign, convey and deliver to Assignee, and Assignee has agreed to purchase, acquire, and accept from the Assignors, the Assets, all upon the terms and subject to the conditions set forth in the Purchase Agreement, which Assets include the Assigned Trademarks; and

WHEREAS, this Assignment is being executed and delivered pursuant to Sections 4.03(b) and 4.04(a) of the Purchase Agreement.

NOW, THEREFORE, in accordance with the Purchase Agreement and in consideration of the premises and the mutual agreements and covenants set forth in this Assignment and the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the parties hereby agree as follows:

1. **Assignment.** Each of the Assignors hereby sells, transfers, assigns, conveys and delivers to Assignee all of such Assignor’s right, title and interest throughout the world in, to and under, the Assigned Trademarks, together with that portion of such Assignor’s business connected with the use of and symbolized by the Assigned Trademarks, and all past and present goodwill associated therewith or symbolized thereby, all common law rights thereto, all registrations that have been or may be granted thereon, all applications for registrations thereof, and all records and files related thereto, the right to claim priority in accordance with international treaties and conventions, the right to all income, royalties, damages and payments hereafter due or payable with respect to the Assigned Trademarks, the right to register, prosecute, maintain and defend the Assigned Trademarks before any public or private agency, office or registrar, the right to sue and recover damages for all causes of action (either in law or in equity) including for past, present and future infringement and dilution of the Assigned Trademarks, and all rights of indemnity, warranty rights, rights of contribution, rights to refunds, rights of reimbursement and other rights of recovery, including rights to insurance proceeds (regardless of whether such rights are currently exercisable) related to such Assigned Trademarks. The assignments contemplated herein are meant to be absolute assignments and not by way of security. Each of the Assignors hereby

authorizes the Commissioner of Patents and Trademarks in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational authorities, to record Assignee as the assignee of all of such Assignor's right, title and interest in, to and under the Assigned Trademarks and to deliver to Assignee, and to Assignee's attorneys, agents, successors or assigns, all official documents and communications.

2. Further Assurances. Each of the Assignors agree to execute and deliver any and all affidavits, testimonies, declarations, oaths, samples, exhibits, specimens, powers of attorney and other documentation, and otherwise agree to assist Assignee, its successors and assigns as reasonably requested by Assignee to effect the terms of this Assignment, in each case at the Assignee's sole cost and expense.

3. Terms of Purchase Agreement; Conflicts. The scope, nature, and extent of the Assets are expressly set forth in the Purchase Agreement. Nothing contained herein changes, amends, extends, or alters (nor should it be deemed or construed as changing, amending, extending, or altering) the terms or conditions of the Purchase Agreement in any manner whatsoever. This instrument does not create or establish rights, liabilities or obligations not otherwise created or existing under or pursuant to the Purchase Agreement. The parties hereto acknowledge and agree that the representations, warranties, covenants, agreements, and indemnities contained in the Purchase Agreement will not be superseded hereby but will remain in full force and effect to the full extent provided therein. In the event of any conflict between the provisions of this Assignment (including the Exhibits) and the provisions of the Purchase Agreement (including the Disclosure Schedules and Exhibits), the provisions of the Purchase Agreement shall control.

4. Waiver. Neither the failure nor any delay by any party in exercising any right, power or privilege under this Assignment or the documents referred to in this Assignment will operate as a waiver of such right, power or privilege, and no single or partial exercise of any such right, power or privilege will preclude any other or further exercise of such right, power or privilege or the exercise of any other right, power or privilege. To the maximum extent permitted by Applicable Laws, (a) no waiver that may be given by a party will be applicable except in the specific instance for which it is given, and (b) no notice to or demand on one party will be deemed to be a waiver of any right of the party hereto that gives such notice or demand to take further action without notice or demand.

5. Severability. The provisions of this Assignment will be deemed severable, and the invalidity or unenforceability of any provision will not affect the validity or enforceability of the other provisions hereof. If any provision of this Assignment, or the application thereof to any Person or any circumstance, is invalid or unenforceable, (a) the parties will negotiate in good faith to modify this Assignment so as to effect the original intent of the parties as closely as possible in an acceptable manner in order that the transactions contemplated hereby are consummated as originally contemplated to the greatest extent possible and (b) the remainder of this Assignment and the application of such provision to other Persons or circumstances will not be affected by such invalidity or unenforceability.

6. Liquidating Trustee. If at any time the Assignors liquidate, their estates are converted to Chapter 7, or otherwise have a trustee or other Representative appointed by the Bankruptcy Court (as applicable, a "**Trustee**"), then (a) such Trustee will be bound to perform the obligations of such

Assignor and will be entitled to exercise the rights of such Assignor under this Assignment, and (b) with respect to each of the Assignor's Assigned Trademarks that are abandoned (if any) following the date hereof, such Assignor grants to such Trustee a power of attorney for purposes of performing such Assignor's obligations under Section 2.06 of the Purchase Agreement with respect to such abandoned Assigned Trademarks. The Assignors acknowledge and agree that the power of attorney granted to such Trustee (if any) pursuant to the foregoing clause (b) is coupled with an interest and will be irrevocable. Further, such power of attorney will also be granted to the Assignee for purposes of performing such Assignor's obligations under Section 2.06 of the Purchase Agreement with respect to such abandoned Assigned Trademarks, as determined by the Assignee, and in the event the Assignee exercises such power of attorney, the Trustee will not commit any act or take any action that is inconsistent with such exercise by the Assignee, except as requested in writing by the Assignee.

7. Governing Law; Consent to Jurisdiction and Venue; Jury Trial Waiver.

(a) Except to the extent the mandatory provisions of the Bankruptcy Code apply, this Assignment will be governed by, and construed in accordance with, the laws of the State of Delaware applicable to contracts made and to be performed entirely in such state without regard to principles of conflicts or choice of laws or any other law that would make the laws of any other jurisdiction other than the State of Delaware applicable hereto.

(b) Without limitation of any party's right to appeal any Order of the Bankruptcy Court, (i) the Bankruptcy Court will retain exclusive jurisdiction to enforce the terms of this Assignment and to decide any claims or disputes, which may arise or result from, or be connected with, this Assignment, any breach or default hereunder, or the transactions contemplated hereby and (ii) any and all claims relating to the foregoing will be filed and maintained only in the Bankruptcy Court, and the parties hereby consent and submit to the exclusive jurisdiction and venue of the Bankruptcy Court and irrevocably waive the defense of an inconvenient forum to the maintenance of any such Proceeding; provided that, if the Bankruptcy Cases are closed pursuant to Section 350 of the Bankruptcy Code, the parties agree to unconditionally and irrevocably submit to the exclusive jurisdiction of the Delaware Chancery Court or, if such court will not have jurisdiction, any federal court located in the State of Delaware or other Delaware state court, and any appellate court from any thereof for the resolution of any such claim or dispute. The parties each hereby irrevocably waive, to the fullest extent permitted by Applicable Laws, the defense of an inconvenient forum to the maintenance of any such Proceeding. The parties each consent to service of process by mail (in accordance with Section 14.02 of the Purchase Agreement) or any other manner permitted by Applicable Law.

(c) THE PARTIES HEREBY IRREVOCABLY WAIVE ALL RIGHT TO TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM (WHETHER BASED IN CONTRACT, TORT OR OTHERWISE) ARISING OUT OF OR RELATING TO THIS ASSIGNMENT OR THE ACTIONS OF ANY PARTY OR SUCH PARTY'S REPRESENTATIVES IN THE NEGOTIATION OR PERFORMANCE HEREOF.

8. Entire Agreement; Amendment. This Assignment, together with the Purchase Agreement and the other Transaction Documents, supersede all prior agreements between the Assignors and the Assignee with respect to the subject matter hereof and thereof and constitute a complete and

exclusive statement of the terms of the agreements between the Assignors and Assignee with respect to the subject matter hereof and thereof. Except as permitted under Section 2.05(c) or Section 2.07 of the Purchase Agreement, this Assignment, including all exhibits hereto, may not be amended, modified or supplemented, or the terms hereof waived, except by a written agreement executed by all of the parties. Notwithstanding the foregoing, this Section 8, to the extent the proposed amendment to any such Section is adverse to any Debt Financing Source, may not be amended without the consent of such Debt Financing Source.

9. Counterparts. This Assignment and any amendment hereto may be executed in one (1) or more counterparts, each of which will be deemed to be an original of this Assignment or such amendment and all of which, when taken together, will constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment or any amendment hereto by email attachment will be effective as delivery of a manually executed counterpart of this Assignment or such amendment, as applicable.


