RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of May 7, 2020, by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as Administrative Agent and Collateral Agent (in such capacities, the “Administrative Agent”), in favor of BEAUTYGE II, LLC (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement (defined below) or the Canadian Trademark Security Agreement (defined below), as applicable, or if not defined therein, in the Guarantee and Collateral Agreement (defined below).

WHEREAS, the Grantor is a party to that certain (i) Term Loan Guarantee and Collateral Agreement, dated as of August 6, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”) in favor of the Administrative Agent, (ii) Trademark Security Agreement, dated as of August 6, 2019, in favor of the Administrative Agent (the “Trademark Security Agreement”), pursuant to which the Grantor granted to the Administrative Agent a lien on and security interest in all right, title and interest of the Grantor in, to and under the Trademark Collateral as defined therein (the “US Trademark Collateral”), and (iii) Trademark Security Agreement, dated as of August 6, 2019, in favor of the Administrative Agent (the “Canadian Trademark Security Agreement”), pursuant to which the Grantor granted to the Administrative Agent a lien on and security interest in all right, title and interest of the Grantor in, to and under the Trademark Collateral as defined therein to include the Canadian registrations and applications listed in Schedule A attached thereto (the “Canadian Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 6713, Frame 0027 on August 6, 2019;

WHEREAS, the Canadian Trademark Security Agreement was filed with the Canadian Intellectual Property Office and was placed by the Canadian Intellectual Property Office with respect to the Canadian Trademark Collateral on November 18, 2019;

WHEREAS, the Grantor has requested that the Administrative Agent terminate, release and discharge fully its lien on and security interest in all right, title and interest of the Grantor in, to and under the US Trademark Collateral, including each trademark and trademark application listed on the attached Schedule A hereto, and execute a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its lien on and security interests in the US Trademark Collateral as herein provided;

WHEREAS, the Grantor has requested that the Administrative Agent terminate, release and discharge fully its lien on and security interest in all right, title and interest of the Grantor in, to and under the Canadian Trademark Collateral, including each trademark and trademark application listed on the attached Schedule B hereto, and execute a document suitable for recording in the Canadian Intellectual Property Office to evidence the release of its lien on and security interests in the Canadian Trademark Collateral as herein provided.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, without representation or warranty of any kind, hereby releases, relinquishes and discharges, with respect to the Grantor, all of its lien on and security interest in and to all of the Grantor’s right, title, and interest in, to and under the US Trademark Collateral and the Canadian Trademark Collateral, and re-assigns to the Grantor any and all right, title or interest it may have in such US Trademark Collateral and Canadian Trademark Collateral.

The Administrative Agent hereby authorizes each of Stikeman Elliott LLP, the Grantor, or the Grantor's authorized representatives to record this Release with the United States Patent and Trademark Office, the Canadian Intellectual Property Office and/or any other applicable governmental office or agency. The Administrative Agent agrees to execute and deliver to the Grantor other instruments and other documents as may be necessary to release the lien on and security interest in the US Trademark Collateral which had been granted under the Trademark Security Agreement and in the Canadian Trademark Collateral which had been granted under the Canadian Trademark Security Agreement.

THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK (OTHER THAN ANY MANDATORY PROVISIONS OF LAW RELATING TO THE LAW GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY INTEREST).
