TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), dated as of May 13, 2020, is executed by SCOTT LAKE HOLDINGS INC.  - (iv) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right, but no obligation, to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
- (b) Agent represents and warrants that they have the full power and authority to execute this Termination.

(c) Agent authorizes and requests the Trademark Division of the United States Patent and Trademark Office to record this Termination.
