





EXHIBIT A
PLAN OF CONVERSION

This Plan of Conversion ("Plan"), effective as of April 15, 2020, is made by Ilsco Corporation, an Ohio corporation (the "Corporation" and "Converting Entity"):

1. Recitals.

(a) The Corporation will convert into an Ohio limited liability company pursuant to the filing of the Articles of Organization and Certificate of Conversion in Ohio on or about the date hereof, to be effective as of the date hereof.

(b) The Corporation was originally organized as an Ohio for profit corporation.

(c) The Corporation deems it advisable and for the benefit of the Corporation and its shareholder that the Corporation convert into an Ohio limited liability company on the terms and conditions hereinafter set forth (the "Conversion").

2. Conversion. At the effective time of the Conversion, the Corporation shall be converted into an Ohio limited liability company by the name of Ilsco, LLC (the "Resulting Company") and shall continue its existence under the laws of the State of Ohio.

3. Articles of Organization. The Resulting Company shall file Articles of Organization pursuant to the provisions provided under §1705 of the Ohio Revised Code.

4. Terms of Conversion. At the effective time of the Conversion, all outstanding shares in the Corporation shall be cancelled and transferred into 100 common units in the Resulting Company.

5. Right to Abandon or Amend Conversion. This Plan may be amended or terminated and the Conversion abandoned at any time prior to the filing of the Certificate of Conversion and Articles of Organization of the Resulting Company.

6. Effective Time of Conversion. The Conversion shall be effective as of the date of filing the Certificate of Conversion and Articles of Organization of the Resulting Company with the Ohio Secretary of State.
