RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of June 1, 2020, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, in its capacity as administrative agent and collateral agent for certain secured parties under the security agreements referred to below (in such capacities, the “**Administrative Agent**”), in favor of Craftworks Restaurants & Breweries, Inc., a Delaware corporation, Logan’s Roadhouse, Inc., a Tennessee corporation, Big River Breweries, Inc., a Tennessee corporation, GB Acquisition, Inc., a Tennessee corporation, Wadsworth Old Chicago, Inc., a Colorado corporation, Walnut Brewery, Inc., a Colorado corporation, Rock Bottom Restaurants, Inc., a Delaware corporation, and Gordon Biersch Brewery Restaurant Group, Inc., a Tennessee corporation (collectively, the “**Grantors**”).

WHEREAS, reference is hereby made to (a) that certain Trademark Security Agreement, dated as of November 15, 2010, by certain Grantors in favor of the Administrative Agent and recorded in the records of the United States Patent and Trademark Office on November 24, 2010 at Reel/Frame 4491/0762; (b) that certain Intellectual Property Security Agreement, dated as of August 18, 2015, by certain Grantors in favor of the Administrative Agent and recorded in the records of the United States Patent and Trademark Office on August 24, 2015 at Reel/Frame 5606/0746; (c) that certain Trademark Security Agreement, dated as of November 1, 2018, by certain Grantors in favor of the Administrative Agent and recorded in the records of the United States Patent and Trademark Office on January 8, 2019 at Reel/Frame 6519/0327; and (d) that certain Trademark Security Agreement Supplement, dated as of January 14, 2020, by certain Grantors in favor of the Administrative Agent and recorded in the records of the United States Patent and Trademark Office on January 21, 2020 at Reel/Frame 6842/0363.


WHEREAS, pursuant to the above referenced security agreements, each Grantor granted to the Administrative Agent a security interest in and continuing lien on all of each Grantor’s right, title and interest in, to and under those trademarks set forth on Schedule A hereto (collectively, the “**Trademark Collateral**”).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Administrative Agent hereby (i) terminates and releases all security interests and continuing liens granted by each Grantor in favor of the Administrative Agent in the Trademark Collateral; (ii) assigns, transfers and delivers to the Grantors all of its right, title and interest in, to and under the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof; (iii) authorizes each Grantor or its designee to make filings with the United States Patent and Trademark Office and to take further actions necessary to evidence the release and termination of the Administrative Agent’s security interests in and liens on the Trademark Collateral; and (iv) authorizes the governing body of the United States Patent and Trademark Office to record this Release.


