RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of June 12, 2020 (the "Effective Date"), is made by MITSUI & CO. (U.S.A.), INC. (the "Secured Party") in favor of Spaceflight, Inc., a Washington corporation ("Spaceflight"), Spaceflight Industries, Inc., a Delaware corporation ("SFI"), SFI IP Holdco, LLC, a Delaware limited liability company ("IP Holdco"), and BlackSky Global LLC, a Delaware limited liability company ("BlackSky" and together with Spaceflight, SFI and IP Holdco, the "Grantors").

WHEREAS, pursuant to that certain Security Agreement, dated as of October 31, 2019, by and among the Secured Party, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantors granted to the Secured Party a security interest in certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered the Grant of Trademark Security Interest, dated as of October 31, 2019 (the "<u>Trademark Security Agreement</u>"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 1, 2019 at Reel/Frame 6785/0932;

WHEREAS, certain Released Trademark Collateral (as hereinafter defined) (such Released Trademark Collateral, the "<u>IP Holdco Trademark</u>"), was subsequently assigned by IP Holdco to Spaceflight pursuant to that certain IP Assignment and License Agreement dated as of June 12, 2020;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

- 1. <u>Defined Terms</u>. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.
- 2. <u>Release</u>. The Secured Party, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in the trademark registrations and trademark applications set forth on <u>Schedule A</u> attached hereto and all Proceeds of the foregoing, arising under the Security Agreement and the Trademark Security Agreement (the "<u>Released Trademark Collateral</u>"). If and to the extent that the Secured Party has acquired any right, title or interest in and to the Released Trademark Collateral under the Trademark Security Agreement, the Secured Party, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor that is the owner of such Released Trademark Collateral or, in the case of the IP Holdco Trademark, to Spaceflight as IP Holdco's successor-in-interest.
- 3. <u>Termination</u>. The Secured Party, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.
- 4. <u>Further Assurances</u>. The Secured Party agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by each Grantor or, in the case of the IP Holdco Trademark, by Spaceflight, at such

Grantor's or, in the case of the IP Holdco Trademark, Spaceflight's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. <u>Governing Law</u>. This Release shall be governed exclusively under the laws of New York.
