

This Confirmatory Trademark Assignment (this "Assignment") is entered into as of the last date noted below, by and between **STRYKER EUROPEAN HOLDINGS LLC**, a limited liability company incorporated under the laws of the State of Delaware, having its registered agent's address at Corporation Trust Center, 1209 Orange Street, Wilmington, Delaware 19801, United States of America (the "Assignor"), and **STRYKER EUROPEAN OPERATIONS LIMITED**, a private company limited by shares, incorporated under the laws of Ireland under company number 631711 and with its registered office at Anngrove, IDA Business & Technology Park, Carrigtwohill, County Cork, T45HX08 IRELAND (the "Assignee"). Assignor and Assignee are collectively referred to as the "Parties" and individually referred to as a "Party."

2. Assignor hereby agrees, without further consideration and without expense to the Assignor, to sign all documents and to perform all other lawful acts which the Assignee may reasonably request to make this Assignment of the Trademark Rights fully effective.


3. This Assignment shall be binding upon, inure to the benefit of, and be enforceable by, the Parties and their respective successors and permitted assigns.

4. This Assignment shall be governed by and construed in accordance with the laws of the State of Michigan, United States of America.

5. This Assignment may be executed and delivered (including electronically) in one or more counterparts, and by the Parties in separate counterparts, each of which when executed shall be deemed to be an original, but when taken together shall constitute one and the same agreement.
