ASSIGNMENT AND ASSUMPTION OF SECURITY INTEREST IN TRADEMARKS

This ASSIGNMENT AND ASSUMPTION OF SECURITY INTEREST IN TRADEMARKS (this "Assignment and Assumption") effective as of June 16, 2020 ("Effective Date") is made by WELLS FARGO BANK, NATIONAL ASSOCIATION having an address of 1525 West W.T. Harris Blvd, Charlotte, North Carolina 28262, as resigning Collateral Agent, as assignor ("Assignor") and WILMINGTON SAVINGS FUND SOCIETY, FSB having an address of 500 Delaware Avenue, Wilmington, Delaware 19801, as successor Collateral Agent, as assignee ("Assignee");

WHEREAS, FTS INTERNATIONAL, INC. (the "Grantor") and Assignor entered into that certain Trademark Security Agreement dated April 16, 2014 (the "2014 Trademark Agreement"), that certain Trademark Security Agreement dated March 21, 2015 (the "2015 Trademark Agreement") and that certain Trademark Security Agreement dated June 22, 2015 (the "Restated 2015 Trademark Agreement", and together with the 2014 Trademark Agreement and the 2015 Trademark Agreement, collectively, the "Trademark Agreements") pursuant to that certain Term Loan Agreement dated as of April 16, 2014 among and between Grantor, Assignor and the Lenders (as amended, restated, supplemented, or otherwise modified from time to time, the "Term Loan Agreement"), pursuant to which Assignor received from Grantor a continuing security interest in certain trademark rights set forth in the Trademark Agreements, including, but not limited to, the trademarks set forth on Exhibit A, ("Trademark Collateral").

WHEREAS, the 2014 Trademark Agreement was recorded at the United States Patent and Trademark Office ("<u>USPTO</u>") at Reel 5262 Frame 0745, the 2015 Trademark Agreement was recorded at the USPTO at Reel 5497 Frame 0945 and the Restated 2015 Trademark Agreement was recorded at the USPTO at Reel 5557 Frame 0764.

WHEREAS, pursuant to that certain Agency Resignation, Appointment, Acceptance and Waiver Agreement dated as of the date hereof by and among Assignor as resigning agent and Assignee as succeeding agent, among other parties ("Successor Agreement"), Assignor has assigned and transferred to Assignee all of all of its rights, powers, privileges and duties under the Term Loan Agreement, (including, without limitation, its Liens and security interests in the Collateral).

NOW THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the parties hereto agree as follows:

- 1. Terms not otherwise defined herein shall have the meanings assigned to them under the Term Loan Agreement.
- 2. Assignor hereby, pursuant to the terms of the Successor Agreement, assigns and transfers to Assignee, and Assignee hereby accepts, all of Assignor's rights, title, interest, responsibilities, duties and obligations in, to and under the Trademark Agreements.

- 3. Following the execution of this Assignment and Assumption, it will be delivered to Assignee for recordation at the USPTO. The parties hereby authorize and request the Commissioner for Trademarks to record this Assignment and Assumption in the USPTO with respect to the Trademark Collateral registered thereat.
- 4. This Assignment and Assumption has been entered into pursuant to and in conjunction with the Successor Agreement, which is hereby incorporated by reference herein. The provisions of the Successor Agreement shall supersede and control over any conflicting or inconsistent provision herein.
- 5. This Assignment and Assumption shall be governed by and construed in accordance with the laws of the State of New York.
- 6. This Assignment and Assumption may be executed in multiple counterparts (including delivery by PDF), each of which when so executed and delivered shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
