**MEMORANDUM AND NOTICE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

**June 19, 2020**

**CARO NUT COMPANY**, a California corporation ("Caro Nut"), **WILD FRIENDS FOODS, INC.**, a Delaware corporation ("Wild Friends"), and **CANDOR-AGS, INC.**, a California corporation ("Parent"; and together with Caro Nut and Wild Friends, each, a "Debtor" and collectively, the "Debtors"), each hereby acknowledges that it has granted to **CYPRIMUM INVESTORS V AIV I LP**, a Delaware limited partnership ("Cyprium V"), and **CYPRIMUM PARALLEL INVESTORS V LP**, a Delaware limited partnership ("Cyprium Parallel" and, together with Cyprium V, "Lenders" and, individually, a "Lender"), as Lenders under the Loan Agreement referred to below, whose address is c/o Cyprium Investment Partners LLC, 200 Public Square, Suite 2020, Cleveland, Ohio 44114, a security interest in and to all of such Debtor's right, title and interest in and to the trademarks and trademark registrations which are identified on Exhibit A attached hereto and herein incorporated by this reference owned by the applicable Debtor (the "Trademarks"), together with the goodwill and assets of the business, as set forth in the Loan Documents (as defined below).

The terms and conditions of the aforementioned security interest are contained in that certain (a) Senior Subordinated Loan and Security Agreement dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement") by and among Caro Nut, Wild Friends, and Lenders and (b) Security Agreement dated as of the date hereof by and among Parent, for the benefit of Lenders (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Parent Security Agreement"; and together with the Loan Agreement and the other documents executed in connection therewith, collectively, the "Loan Documents"), each for the benefit of Lenders, as security for the Obligations (as defined in the Loan Agreement) as set forth in the applicable Loan Documents. Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Lenders may have in any other collateral described in the Loan Documents or otherwise.

The parties hereby agree that this Memorandum and Notice of Security Interest in Intellectual Property and all claims shall be governed by the law of the State of New York, without giving effect to any conflict of law principles except federal laws relating to national banks and Sections 14.14, 14.15 and 14.16 of the Loan Agreement are hereby incorporated by reference. Each Debtor hereby authorizes the filing of this Memorandum and Notice of Security Interest in Intellectual Property with the United States Patent and Trademark Office.


