**ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS**

**THIS ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS** (this “Assignment”) is made and entered into as of June 19, 2020, by Wilmington Trust, National Association, a national banking association, having offices at 50 South Sixth Street, Suite 1290 Minneapolis, MN 55402, as successor Trustee and Collateral Agent (the “Successor Trustee”), and Wells Fargo Bank, National Association, a national banking association duly organized and existing under the laws of the United States of America having a corporate trust office at 150 East 42nd Street, 40th Floor, New York, NY 10017, as resigning Trustee and Collateral Agent (the “Resigning Trustee”). Capitalized terms used but not otherwise defined herein shall have the same meaning ascribed to such terms in the Indenture (as defined below).

**RECITALS**

WHEREAS, LSC Communications, Inc., a Delaware corporation having its principal office at 191 N. Wacker Drive, Chicago, Illinois 60606 (the “Company”) appointed the Resigning Trustee as the Trustee, Registrar, Custodian, Paying Agent, Transfer Agent and Collateral Agent pursuant to an Indenture dated as of September 30, 2016, (as may be supplemented and amended from time to time, the “Indenture”), entered into by the Company, the Subsidiary Guarantors from time to time party thereto and the Resigning Trustee;

WHEREAS, pursuant to (i) the Indenture, (ii) a Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) dated as of September 30, 2016, among (a) the Company, Courier Communications LLC, Courier Kendallville, Inc., Courier New Media, Inc., Dover Publications, Inc., LSC Communications MM LLC, LSC Communications US, LLC, LSC International Holdings, Inc., National Publishing Company, Creel Printing, LLC, Fairrington, LLC (n/k/a LSC Communications Logistics, LLC), Publishers Press, LLC, and Quality Park, LLC, as Grantors (collectively, the “Grantors”)<sup>1</sup> and (b) Resigning Trustee, as collateral agent, (iii) a Trademark Security Agreement, dated as of September 30, 2016, by LSC Communications US, LLC, Courier Communications LLC and National Publishing Company, in favor of Resigning Trustee, in its capacity as collateral agent pursuant to the Indenture recorded at the United States Patent and Trademark Office (the “USPTO”) on October 4, 2016 at Reel/Frame 5890/0324, (iv) a Trademark Security Agreement, dated as of October 6, 2017, by Publishers Press, LLC, in favor of Resigning Trustee, in its capacity as collateral agent pursuant to the Indenture recorded at USPTO on October 9, 2017 at Reel/Frame 6177/0740, and (v) a Trademark Security Agreement, dated as of December 8, 2017, by Quality Park, LLC, in favor of Resigning Trustee, in its capacity as collateral agent pursuant to the Indenture recorded at USPTO on December 11, 2017 at Reel/Frame 6225/0902, (items (iii), (iv) and (v), as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreements”), the Grantors have granted to the Resigning Trustee a continuing security interest in, and lien on, all of their right, title and interest in, to and under the Trademark Collateral (as such term is defined in the

Trademark Security Agreements), including, without limitation, those trademark registrations and applications set forth on Schedule I hereto;

WHEREAS, pursuant to an Instrument of Resignation, Appointment and Acceptance, dated as of June 16, 2020, (as may be supplemented and amended from time to time, the “Successor Agent Agreement”) by and among Company, the Subsidiary Guarantors party thereto, Successor Trustee, and Resigning Trustee, the Resigning Trustee has resigned as Trustee, Registrar, Custodian, Paying Agent, Transfer Agent and Collateral Agent under the Indenture, and in its related roles under the other Notes Documents and the Successor Trustee has accepted the appointment as Trustee, Registrar, Custodian, Paying Agent, Transfer Agent and Collateral Agent under the Indenture, and the related roles under the other Notes Documents, as applicable; and

WHEREAS, the Resigning Trustee and the Successor Trustee desire to enter into this Assignment to evidence the assignment by the Resigning Trustee to the Successor Trustee of all of the Resigning Trustee’s right, title and interest in, to and under the Indenture, the Security Agreement and the Trademark Security Agreements, including, without limitation, the Resigning Trustee’s security interest in, and lien on, the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Resigning Trustee and the Successor Trustee hereby covenant and agree as of the date first above written as follows:

1. **Relation to Indenture.** In the event of any conflict between this Assignment and the Indenture, the Indenture shall control.
2. **Assignment.** The Resigning Trustee hereby transfers, assigns, grants and conveys to the Successor Trustee for the ratable benefit of the Secured Parties all of its right, title and interest in, to and under the Security Agreement and the Trademark Security Agreements, including, without limitation, its security interest in, and lien on, the Trademark Collateral, and the Successor Trustee hereby accepts and assumes the foregoing assignment and all of such right, title, interest, security interests and liens. This Assignment is being executed and delivered in accordance with the Successor Agent Agreement.
3. **Recordation.** Effective upon the date first written above, the Resigning Trustee authorizes that the USPTO and any other similar governmental authority, as applicable, record the Successor Trustee as the Successor Trustee for the Secured Parties in the Trademark Collateral.
4. **Choice of Laws.** This Assignment shall be governed by the laws of the State of New York.
5. **Counterparts.** This Assignment may be executed in any number of counterparts, each of which, when so executed and delivered, shall be deemed an original, but all counterparts shall constitute but one Assignment. Delivery of a counterpart hereof by facsimile transmission or


