This NOTICE OF SUCCESSION OF AGENCY (this "Notice"), dated as of June 22, 2020 (the "Effective Date"), is executed by BANK OF AMERICA, N.A., in its capacity as resigning Administrative Agent and resigning Collateral Agent under the Credit Agreement (as defined below) (the "Prior Agent"), and WILMINGTON SAVINGS FUND SOCIETY, FSB, in its capacity as successor Administrative Agent and successor Collateral Agent under the Credit Agreement (the "Successor Agent"). Capitalized terms used herein but not otherwise defined shall have the meanings ascribed thereto in the Credit Agreement.

WHEREAS, pursuant to that certain First Lien Credit Agreement, dated as of May 30, 2019, by and among TRAVELPORT FINANCE (LUXEMBOURG) S.À.R. L. (the "Borrower"), Prior Agent and certain other parties thereto (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Prior Agent and certain grantor parties identified on the signature page hereto (the "Grantors") entered into that certain Security Agreement, dated as of May 30, 2019 (the "Security Agreement"), that certain Grant of Security Interest in Trademark Rights, dated as of May 30, 2019, in respect of certain trademarks set forth on Schedule A attached thereto and owned by Travelport, LP and that certain Grant of Security Interest in Trademark Rights, dated as of May 30, 2019, in respect of certain trademarks set forth on Schedule A attached thereto and owned by Travelport Inc. (together, the "Trademark Security Agreements"), pursuant to which the Grantors, as applicable, granted a security interest in and to certain Collateral;

WHEREAS, each of the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on June 4, 2019 at Reel/Frame 6661/0712 and Reel/Frame 6661/0768, respectively;

WHEREAS, the Prior Agent, the Successor Agent, the Borrower and certain other credit parties have entered into that certain First Lien Agency Resignation, Appointment, Assignment and Assumption Agreement, dated as of June 19, 2020 (the "Resignation Agreement"), whereby the Prior Agent resigned as Administrative Agent and Collateral Agent under the Credit Agreement and is succeeded to and replaced by the Successor Agent as successor Administrative Agent and successor Collateral Agent under the Credit Agreement;

- 2. Succession and Replacement of Agency. Pursuant to the terms and conditions set forth in the Resignation Agreement, the Prior Agent has ceased to be Administrative Agent and Collateral Agent under such capacity and is succeeded to and replaced by the Successor Agent as Administrative Agent under such capacity. Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the Collateral originally granted to the Prior Agent under the Trademark Security Agreements, as applicable, which security interest is now succeeded by and transferred to the Successor Agent.
