AND WHEREAS ASSIGNEE is desirous of acquiring the rights to the Trademark:

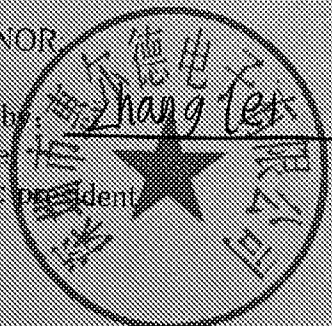
