RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of July 2, 2020 (the “Effective Date”), is made by Citibank, N.A., in its capacity as Administrative Agent (the “Agent”), in favor of the grantor parties identified on the signature page hereto (each individually a “Grantor”, and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Security Agreement, dated as of August 19, 2011, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as Administrative Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, certain of the Grantors executed and delivered (i) a Trademark Security Agreement, dated as of August 19, 2011 (the “Trademark Security Agreement No. 1”), for recordal with the United States Patent and Trademark Office; (ii) a Trademark Security Agreement, dated as of April 26, 2013 (the “Trademark Security Agreement No. 2”), for recordal with the United States Patent and Trademark Office; and (iii) a Trademark Security Agreement, dated as of July 21, 2017 (the “Trademark Security Agreement No. 3”, and, together with the Trademark Security Agreement No. 1 and the Trademark Security Agreement No. 2, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, (i) the Trademark Security Agreement No. 1 was recorded with the United States Patent and Trademark Office on August 19, 2011 at Reel/Frame 004608/0262; (ii) the Trademark Security Agreement No. 2 was recorded with the United States Patent and Trademark Office on April 30, 2013 at Reel/Frame 5017/0283; and (iii) the Trademark Security Agreement No. 3 was recorded with the United States Patent and Trademark Office on July 21, 2017 at Reel/Frame 6110/0959;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to Trademark Collateral, including the trademark registrations and applications set forth Schedule I attached hereto, arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.


