**NOTICE OF SUCCESSION OF AGENCY
REEL/FRAME 6056/0624**

This NOTICE OF SUCCESSION OF AGENCY (this “Notice”), dated as of July 1, 2020 (the “Effective Date”), is executed by JPMorgan Chase Bank, N.A., in its capacity as Collateral Agent under the Credit Agreement (as defined below) (the “Prior Collateral Agent”), and MUFG Union Bank, N.A. in its capacity as Collateral Agent pursuant to the Agency Replacement Agreement (as defined below) (the “Successor Collateral Agent”).

WHEREAS, pursuant to that certain Credit Agreement, dated as of May 12, 2017 (as amended, supplemented, amended and restated or otherwise modified prior to the date hereof, the “Credit Agreement”), by and among MaxLinear, Inc. (the “Borrower”), the Prior Collateral Agent and certain other parties thereto, the Prior Collateral Agent and certain grantor parties identified on the signature page thereto (the “Grantors”) entered into that certain Security Agreement, dated as of May 12, 2017 (as amended, supplemented, amended and restated or otherwise modified prior to the date hereof, the “Security Agreement”), and the Trademark Security Agreement, dated as of May 12, 2017 (the “Trademark Security Agreement”), pursuant to which the Grantors granted a security interest in and to certain collateral;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 12, 2017 at Reel/Frame 6056/0624, with respect to the trademarks identified on Schedule A attached hereto; and

WHEREAS, the Prior Collateral Agent, the Successor Collateral Agent, the Borrowers and certain other parties have entered into that certain Resignation, Consent and Appointment Agreement, dated as of July 1, 2020 (the “Agency Replacement Agreement”), whereby the Prior Collateral Agent resigned as Collateral Agent and is succeeded to and replaced by the Successor Collateral Agent as Collateral Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Agency Replacement Agreement.

2. Succession and Replacement of Agency. Pursuant to the terms and conditions set forth in the Agency Replacement Agreement, the Prior Collateral Agent has ceased to be Collateral Agent under such capacity and is succeeded to and replaced by the Successor Collateral Agent as Collateral Agent under such capacity. Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the collateral originally granted to the Prior Collateral Agent under the Trademark Security Agreement, which security interest is now succeeded by and transferred to the Successor Collateral Agent.


