RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of June 30, 2020, by **PACIFIC WESTERN BANK**, a California state chartered bank ("Lender") in favor of **PANGO INC. (formerly known ANCHORFREE INC.)**, a Delaware corporation ("Company") with its principal place of business located at 1800 Seaport Boulevard, Redwood City, CA 94063.

Recitals

WHEREAS Company granted to Lender a security interest in all of its right, title and interest in, to and under its intellectual property, including without limitation the patents and trademarks described on Exhibits A and B attached hereto, respectively, and further including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisionals, continuations, renewals, extensions and continuations-in-part thereof (collectively, the "Intellectual Property Collateral") under an Intellectual Property Security Agreement dated as of November 27, 2018 and an Amended and Restated Intellectual Property Security Agreement dated as of June 18, 2020 (collectively, the "Security Agreement"), and recorded with the US Patent and Trademark Office as set forth on Exhibits A and B.


WHEREAS Company has no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to release its security interest in the Intellectual Property Collateral.

Now therefore, Lender agrees that it terminates and releases its security interest in the Intellectual Property Collateral and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property Collateral.
