TERMINATION AND RELEASE OF SECURITY INTEREST

TO: United States Patent and Trademark Office

Ladies and Gentlemen:

Reference is made to (i) that certain Pledge and Security Agreement, dated as of April 2, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among Hart InterCivic, Inc., a Texas corporation (the "Borrower"), Hart Intermediate Holding Company, Inc., a Delaware corporation ("Intermediate Holdings"), Hart Investment Holding Company, Inc., a Delaware corporation ("Holdings"), the other obligors from time to time party thereto and Silver Point Finance, LLC, as collateral agent and administrative agent (in such capacity, the "Collateral Agent") and (ii) that certain Short-Form Trademarks Security Agreement, dated as of April 2, 2019, by the Borrower in favor of the Collateral Agent, which was recorded with the United States Patent and Trademark Office (the "USPTO") on April 9, 2019 at Reel 6613, Frame 0191 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"). Capitalized terms used but not defined herein have the meanings assigned to them in the Security Agreement.

WHEREAS, in connection with certain indebtedness formerly owed by the Borrower to the Secured Parties, the Borrower entered into that Security Agreement and the Trademark Security Agreement pursuant to which the Borrower granted a security interest in favor of the Collateral Agent in and to certain of the Borrower's trademark rights listed on Exhibit A hereto (the "Released Trademark Collateral").

WHEREAS, said indebtedness owed by the Borrower to the Secured Parties has been fully paid and satisfied and in connection therewith, the Collateral Agent is required to terminate and release its security interest in the Released Trademark Collateral.

NOW, THEREFORE, the Collateral Agent covenants and agrees as follows:

1. Without recourse, the Collateral Agent automatically and irrevocably terminates, releases and discharges its security interest in the Released Trademark Collateral and reassigns to the Borrower all right, title and interest of the Collateral Agent in the Released Trademark Collateral pursuant to the Trademark Security Agreement and all proceeds thereof.

2. The Collateral Agent hereby irrevocably authorizes the recordation of this notice of termination and release with the USPTO.
