## TRADEMARK ASSIGNMENT

Assignor does hereby sell, assign, convey and transfer unto Assignee and its successors, assigns and legal representatives, Assignor’s entire right, title and interest in and throughout the world in and to the Trademarks (including any common law rights that may exists and are associated therewith), together with the goodwill symbolized thereby and appurtenant thereto, the same to be held and enjoyed by Assignee, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation all claims for damages or payments by reason of infringement or unauthorized use thereof, along with the right to sue for past infringements and collect same for Assignee’s sole use and enjoyment.
2. Assignor does hereby authorize the Director of the United State Patent and Trademark Office, and the empowered official of any U.S. State, or any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors, assigns or legal representations in accordance with the terms of this instrument.
3. Assignor agrees to execute any further documents or instruments as may be necessary and proper to vest full title in and to the Trademarks and other corresponding rights in Assignee.
4. This Assignment may be executed in multiple counterparts and delivered, submitted and filed electronically, each of which will be deemed an original and all of which together constitute one and the same instrument.

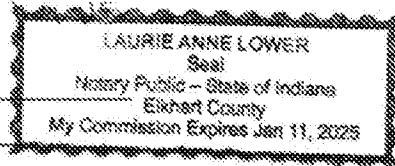
