NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor sells, assignments, transfers and sets over to Assignee, its successors, and assigns, effective the dated of the Agreement, all rights, title, and interest in and to all common law, state and federal trademarks for the TORNADO mark (registered and unregistered, including U.S. Reg. No. 5,678,950), all associated trade dress rights and goodwill symbolized by the same, throughout the world, including the right to recover damages and profits for past infringements of said trademark and trade dress rights. Assignor warrants that it is the legal owner of all rights, title and interest in said transferred trademark and trade dress rights prior to this Assignment, that the trademark and trade dress rights were not otherwise pledged, assigned, or encumbered, and that this Assignment will not infringe on the rights of any other person or entity. Assignor agrees to cooperate with Assignee to execute and deliver all papers, instruments and assignments as may be necessary to confirm the transfer and vesting of these rights, title and interests in and to Assignee.
